



Election calendar 2016



Friday, January 15, 2016 – last day to transmit absentee ballot to UOCAVA voters.

Thursday, January 20, 2015 – deadline for Campaign finance reports to be submitted to clerk's office



Tuesday, February 2, 2016 – Last day to send absentee ballot applications to all certified permanently disable voters (this will be done on January 5th) **ALSO** last day to designate health care facilities for supervised absentee voting – need letter from registrars stating locations and designation

Wednesday, February 10, 2016 – Last day to register to vote and change party enrollment for Presidential Primary. City Clerk office open until 8PM.

Tuesday, February 16, 2016- Nomination papers must be available –can obtain from Secretary of State's office –location of regional distribution TBD (check back first week of Feb.) **ALSO** – last day to test Accuvote machines for primary




Tuesday, March 1, 2016 – Presidential Primary

Saturday, March 5, 2016 – last day for Clerks to mail Presidential Primary results to SOC



Friday, April 15, 2016- Last day to have street lists prepared. **ALSO** last day to notify party chairmen to submit lists of prospective election officers.




Tuesday, May 3, 2016 -5PM – Last day and hour to submit nomination papers to Registrar of Voters for certification of signatures for all offices except statewide and Congress. Clerk’s office open until 5PM


Tuesday, May 10, 2016 5PM- last day and hour for party candidates for statewide and Congress to submit nomination papers to local Registrar of voters for certification. Clerk’s office open until 5PM

Tuesday, May 24, 2016 -5PM – Last day and hour for Registrar of Voters to complete certification of signatures for all offices except statewide and Congress

Tuesday, May 31, 2016 – 5PM – Last day and hour to file nomination papers with the Secretary of the Commonwealth. **ALSO** last day and hour for Registrar of Voters to complete certification on nomination papers for party candidates for statewide and Congress.



Tuesday, June 7, 2016 5PM – Last day and hour to file party nominations with SOC for statewide and Congress.




Friday, July 1, 2016 – last day to have voting list prepared.

Wednesday, July 6, 2016 – 5pm -last day and hour to submit public policy petitions to Registrars of voters for certification of signatures. Clerk’s office open until 5PM


Saturday, July 9 , 2016- may destroy ballots and election materials from 2014 state primary.

Wednesday, July 27, 2016 – 5pm – last day and hour for Registrar of voters to complete certification on public policy petitions



Friday, August 19, 2016 – 5PM – Last day and time to register to voter and to change party enrollment for the State Primaries. Clerk's office open until 8PM


(If not covered by earlier action) – **Thursday, August 11, 2016** – last day to send absentee ballots to all certified permanently disabled voters. **ALSO** last day to designate health care facilities for supervised absentee voting – need letter from registrars stating locations and designation



Tuesday, September 6, 2016 – *May destroy ballots and election material from 2014 state election*

Thursday, September 8, 2016 – State primary


Saturday, September 24, 2016 – last day for city clerk to send results of state primary to SOC.



Tuesday, October 11, 2016 – last day to send absentee ballot applications to all certified permanently disabled voters and last day to designate health care facilities for supervised absentee voting

Wednesday, October 19, 2016 – Last day to register to vote in Presidential and State Election on Nov 8th.
– City clerk's office open until 8PM.

Monday, October 31, 2016 – pre-election campaign finance reports due with OCPF – legislative candidates




Tuesday, November 1, 2016- Last day to post warrant for State and Presidential Election

Friday, November 4, 2016 – Last day to test Accuvote machines

Tuesday, November 8, 2016 – Presidential and State Election

Wednesday, November 23, 2016 – last day for election results to be transmitted to the SOC. **ALSO** last day and hour (5PM) to submit initiative petitions for certification of signatures to Registrars of Voters. Clerk's office open until 5PM



Monday, December 5, 2016 – Last day for Registrars of Voters to complete certification of signatures on initiative petitions.

Wednesday, December 7, 2016 5PM – last day and hour to file initiative petitions with the SOC
