

The Frozen Shamrock Race Committee will once again be holding the 8th Annual Frozen Shamrock 3-Mile Road Race, in downtown Haverhill at Maria's Family Restaurant on **Sunday, February 22, 2015**. The road race is starting at **1:00 PM**, as in previous years.

The course is as follows:

The race begins in front of Haverhill Lofts at 25 Locust Street, proceeds up Granite Street where it takes a left onto Railroad Square, than takes a right onto Washington Street, left over the Comeau Bridge, bearing right onto Laurel Avenue. At the top of Laurel it takes a left onto Rt. 125 South Main Street to Crescent Street where it takes a left and merges onto Blossom Street. From there we take a right onto South Elm Street to South Pleasant Street where we take a left onto Chadwick/ Middlesex Street. At the end of Middlesex we take a left onto RT. 125, South Main Street. From there we process over the Basilere Bridge and then a left onto Merrimack Street. At Washington Square we take a right onto Emerson Street up to Grand Street, left back onto Locust Street where we finish in front of 36-38 Locust Street

Last year, with the help of the Haverhill Police Department, the event was a huge success.

NOTE: This year we hope to attract 1,000- 1,100 runners.

As you are aware, Gale Associates, Inc. (Gale) has been providing the City of Haverhill, through the Haverhill Police Department (Haverhill), engineering services for the removal and replacement of the asphalt shingles and associated masonry components to address water intrusion into the building. The project is currently near substantial completion, and a preliminary punch list inspection letter has been forwarded to the Contractor of Record (COR).

That said, and as outlined in multiple correspondence letters which had been generated by Gale and discussed with Haverhill, the existing roof insulation system below the roof deck was intended to remain in place, but was found during the construction phase to be improperly configured to promote ventilation under the roof deck system. At Haverhill's request, Gale performed additional site visits, generated a summary report of the findings, and presented an abbreviated scope of work with schematic details for the COR to price certain repair alternatives to further promote ventilation under the shingle system.

Based on information presented by Gale's accounting department, \$32,038.75 has been invoiced, and paid by Haverhill, through October 6, 2014. Based on Gale's Work In Progress (WIPs), an additional \$8,299.50 worth of Gale's consulting are anticipated to be invoiced for both regularly scheduled, and additional construction services for the month of October 2014. This sub-total is therefore valued at \$40,338.25. Based on our understanding of the agreement, the combined Gale compensation for this project is valued at \$44,750.00, which includes the \$3,000 fixed fee for the close-out procedures which have not yet been initiated.

As there are still several additional site visits which are required before the closeout procedures can be initiated by the COR, it is suggested that Haverhill consider increasing Gale's compensation for an additional ~~\$6,000~~ to perform up to three (3) additional site visits, generate the appropriate field reports, and perform an additional inspection of the recently authorized additional construction operations. Gale's services for the construction administration will continue to be invoiced on a time and expense basis in
