MUNICIPAL ORDINANCE

CHAPTER 175

An Ordinance Relating to Loitering

Be it Ordained by the City Council of the City of Haverhill that Chapter 175, of the Code of the City of Haverhill, as amended, being and is hereby further amended as follows:

By adding the following at the end of §175-2:

“No person or group of persons, whether in boats, vehicles or otherwise, shall stand, loiter, remain in and/or about the City-owned Merrimack River boat docks and ramps or the boardwalk adjacent to the Phoenix Row Parking Lot between the hours of 1:00a.m. through 7:00a.m., inclusive, unless joint written permission is obtained from the Mayor or the Chief of Police.”
