## **INCIDENT THAT OCCURRED ON/ABOUT FEBRUARY 26, 2022**

Continued from May 5 2022 meeting.

Jason Petrou appeared for Kruegar Flatbread.

Chairman Edwards commented to Captain Tracy about the heavily redacted report from police leaving very little information. Captain Tracy said he would talk with records department.

Captain Tracy recounted the incident – MV crash on Rosemont St. Driver found walking unsteadily and very fast. Indications that she was intoxicated and failed field sobriety test and had breathalyzer reading of 0.19. She stated she had a couple of drinks after her shift at Kruegars. She also stated in court that she has started a new medication and may have had bad interaction with alcohol. Jason stated the worker admitted to having brought in her own nips. The business typically closes at 9:30PM and workers are usually done by 10:30. Incident occurred at 11:07PM. Worker stated she had drank after her shift ended.

The worker has been with the business for about 25 years and has never had an incident like this in the past. Jason also stated there have been no issues with the business either.Since the incident, Jason has had many meetings with employees on this matter and also with the worker. They are keeping an eye on employees drinking after their shift.

Commissioner Driscoll thanked the HPD for bringing matters like these to the attention of the License Commission.

Chairman Edwards asked if the employees get free drinks after work. Jason said there are no free drinks. Chairman Edwards wanted the time card showing what

time the worker punched out. Captain Tracy said the HPD was satisfied with the business' response and the HPD has no interest in escalating the incident. Commissioner Angus made motion to file this information for any future reference. Commission Driscoll seconded. No public comment. Motion passed unanimously.
