## Investment Consultant Review & Update Report

- Overview of Markets and Performance Report.
- 1.WIC provided a market update as of 2/6/2019. WIC discussed that the December 2018 performance will be available when the partnerships report their Q4-18 results.
- 2. WIC provided an update on the asset transition as of February 2019.
- 3. WIC provided updated performance for Fisher Investments and Putnam as of January 31, 2019.
- 4.WIC provided an update on Global Forest Partners (GFP) 6 and their merger plan. GFP already had the majority votes, but WIC wanted to make the Board aware of what is happening. As indicated in the meeting, Haverhill had a carrying market value of this investment of approximately \$ 5,000.
- 5.WIC provided an update to Global Forest Partners 10 and the recent fires in Southern Tasmania in Australia. Although the situation is fluid, Global Forest Partners reported that 600 of the 26,000 hectares in this investment have been affected by the fire.
