





#### President Sullivan opened the hearing.

Attorney Russell Channen addressed the Council. Special permit application for clients, Dennis and Susan Suslavich, to construct a single-family home on Stanley Drive. The special permit is required because the property is located in the Watershed Protection District. Issued raised with the previous application have been addressed. The project meets the criteria under section 9.2.

Dennis Suslavich addressed the Council stating he has lived in Haverhill for 37 years and has owned a business in town for over 38 years. Needs to downsize from his current home due to major medical issues. This home will be acceptable to his needs later on. He spoke with the neighbors about their concerns and tried to mitigate them and be a good neighbor.

Joseph Serwatka, Engineer, addressed the Council stating that the previous plans have been revied to a single-family home, kept the drainage, added a French drain, rain gardens and revised the grading ensuring now runoff water issues into Pentucket Lake.

#### President Sullivan asked if anyone would like to speak in favor? No one spoke. President Sullivan asked if anyone would like to speak in opposition?

Linda Downey, 5 Quimby, addressed the Council stating she has concerns about the underground water situation on this lot. There is always water across the road, do the French drains address that?

Joseph Serwatka stated every lot in Massachusetts has ground water. It is typically 4-6 feet deep. We are not intercepting ground water. There will be a foundation drain into the rain garden. French drains are swales along the side of the property that will take surface runoff and channel it to catch basins and rain garden and into new drain pipe being installed.

#### President Sullivan closed the hearing.

Councilor comments included project is tremendously improved than what came before the Council in December, good engineering, addressed the water runoff concerns, installation of a new drain line, new line will mitigate icing issues in the winter, worked with neighbors to address their concerns, sustainable design, prefer the single-family owner-occupied home,




