Julio Mejia, 1080 Essex Street Lawrence, Organizer with the Merrimack Valley Project addressed the Council to talk about the Steward Health Care Crisis representing the concerned citizens, nurses, doctors, SCIU committee for interns and residents, and the citizens. The potential closing of the hospital due to bankruptcy is a matter of deep concern for us all. This potential closure threatens the wellbeing of countless residents who rely on these essential services and is a beacon of hope where folks get compassionate life saving care. This would create a public health crisis of immense proportions. It will strip away the critical access to healthcare for many in our community, especially the most vulnerable, and place an enormous strain on our entire healthcare system, especially in the Merrimack Valley. Our community deserves better, we deserve access to quality healthcare, we deserve to keep these institutions open that have served us so well for so long. It demands our immediate attention and action and urges all of you to take a stand in preserving Holy Family Hospital.

Speakers from Merrimack Valley Project, the MNA and the SCIU committee for interns and residents, and residents of the community appeared before the Council. All expressing their concerns with possibility of hospital closure, all deserve quality healthcare, core concern now is what is the State Administration doing including the health office, governor and attorney general offices. Public statements seem to be softening as time goes on. Want a statement directed to the Healy administration and Attorney

General office saying it is not either politically, morally or ethically acceptable that any of these hospitals close. No community is less important than any other community.

Councilors agreed with the concern of the hospital closing, an acute care hospital is as basic as you get for quality of life, concerned with rumors that the Governor may not be prioritizing Haverhill and need to know what is being done.

Councilor Jordan would like to make a motion to send a letter from the Council to Governor Healy, inviting Mayor Barrett and our State Delegation to join with us in the language of the letter. The language suggestion paraphrasing what was said by Dana Simmons that it is "not either politically, morally or ethically acceptable" that the closing of any one hospital is not right for any one city. All of our cities are vitally important, and all our cities need to have local health options for all the reasons stated.

Councilor Lewandowski would like to add to the motion suggesting in the letter to state consideration of Eminent Domain of the hospital. There is no question that this is for a public purpose.

Mayor Barrett stated any communication she has with the state delegation urges them that we must maintain an acute care hospital with full care not just an emergency room, need services for almost 70K residents and cannot be collateral damage.

15.2. Council Vice President Jordan and Councilor Lewandowski request a discussion about possible conditions on new development and potential changes to our zoning ordinances

Councilor Jordan states he has been receiving many emails, constituents coming up to him, as he sure all Councilors have been, concerned about the amount of development, ones already been approved, asking if going to keep continuing to approve all these projects, etc. Think it is important to consider what types of developments we want in the city. Think it is critical to consider what the long-term impact will be of each project being asked to approve. Imperative that each project we approve be revenue neutral. Have had conversations with Bill Pillsbury, Bob Ward, Mayor Barrett, Rob Moore suggesting having a meeting where these things can be "flushed out" and think City Solicitor should also be involved.

Councilor Lewandowski stated as part of this referral, we need to look at our density bonus program where it should and should be and take a global look at zoning. Of particular urgency is the waterfront district and the old paper board site which is 30-40 acres. The zoning as it is now allowing a density bonus in that area which would have a traumatic impact on our city. Density bonuses work in some areas but not all. Would like to make a separate motion to immediately send to our city solicitors for some type of rewording to highlight that particular area/district and come back in a couple of weeks and vote on a change to that particular part of the zoning as it relates to the waterfront district. If we wait and something gets in, you can't change the zoning retroactively and have it have any impact on something that is proposed close to 1000 units in that area. A working group to talk about our zoning and talk about incentivizing for developers is a really good idea. Also think we should take another look at our ADU's. Discussed a report to be given after a year and coming up on that date. Mayor Barrett would be happy to provide a report on ADU's at the next meeting. Concur completely that this is something that we need to do. I am a little leery of having the solicitor make, with my direction, changes to the parcel that used to be the paper board. I will do it, but I would like the Council to have input also.

Councilor Lewandowski stated can send to P&D so long as we get a quick turnaround. Councilor Michitson would like to include the Merrimack Valley Planning Commission and see what kind of models they have.

Councilor Toohey stated he has done some research and data on this and as a body, glad working as a Council and a community going forward on development. See and talk to contractors and developers and the opinion right now is Haverhill is not open for business. Looking forward to sitting in on these discussions. Part of the discussion should include that the Governor is asking communities like ours to build more housing and at the same time, take away the hospital.
