The Chairperson asked Clerk Flynn if he had received the signed green cards for the Abutters notification. The Clerk replied he had received some and the tracking information for the remaining ones.

Chairperson Angus asked if the business was still under construction and not yet open – the applying party confirmed so. The Chairperson commended the party for submitting one of the most complete Liquor License applications she has ever seen. She then asked about their experience in serving alcohol. Ms. Jeesom replied that they have been in the restaurant business for over 10 years and that she had previously been a server and bartender. She added that they had started their own restaurant business in the last few years. Commissioner Koutoulas commented that everything in the application appeared to be in order.

Ms. Dawson replied this was her first time and that she believed she had only been at Circle K since last April. The Chairperson asked if Ms. Dawson was aware of the rules for purchasing alcohol from authorized sources only and Ms. Dawson confirmed so. The Chairperson then asked if the new manager was TIPS certified and she confirmed this as well. Clerk Flynn mentioned a copy of her certificate was included in the application. Chairperson Angus asked if this had been obtained from an online course and the Clerk clarified that it had been obtained prior to the new TIPS rules enacted during the meeting of June 5, 2025. The Commission reminded Ms. Dawson that she would need to renew her certificate in 2028 with a course that meets the new guidelines. Ms. Dawson agreed.

Items 12.1, 12.2, 12.3, and 12.4 were all heard together.

All four businesses in question were present for this discussion. Chairperson Angus mentioned to Mr. Gaiero of G's that she did see his email explaining they had had an incident at the business on the day of the meeting and that she appreciated the communication. The Chairperson continued that the renewal meeting was very important to attend, that the City once again had the ability to have the ABCC present new information, that this meeting was the only time they could gather businesses in one room to go over any new requirements or laws, and that the Police, Fire, and Inspectional Services Departments all take time out of their schedules to attend. She then commented that she was impressed there were only four absentees this year and that businesses would find this meeting is informative. She advised that there were new 304 Occupancy requirements for renewals this year, and that businesses should be prepared for inspections starting the following week. She reminded those present that failure to complete the inspection by November 24th would require liquor licensees to close on November 30th 11:59PM, and failure to submit renewal paperwork by November 24th would require licensees to close on December 31st 11:59PM. The Chairperson concluded by thanking the four for attending and saying she hoped to see them at next year's renewal meeting.

Susan Garland, LLC manager, later had an inquiry about a change of hours for The Solid Slice Pizzeria. The Commission clarified that an application was necessary. Ms. Garland asked if this application would need to wait until the November Commission meeting — Chairperson Angus confirmed so and added that the ABCC would need to acknowledge the application before the new hours could be adopted. The LLC manager asked if this process would take time and the Chairperson replied it would not as it is more so an "acknowledgement" as opposed to an approval, but that the ABCC still needed to be aware of any new hours should an investigator notice a discrepancy between the license hours and hours of operation. The Chairperson reminded Ms. Garland that the current hours would need to be maintained

until the ABCC accepted the new hours. Clerk Flynn told her to reach out to him to start the process.

-Show Cause Hearing: Alleged Violation of Entertainment license – Hosting disapproved activity

- "Queen of Hearts" event hosted on or about September 3, 2025 at 7:00PM

Joseph Michaud, corporation Director and board Chairman, was present for this hearing. The director explained that Ms. Duggan was not feeling well and could not attend the meeting. Chairperson Angus stated that the club had applied to amend their Entertainment license in July 2024 to add "Queen of Hearts" but that this application had been denied. The Chairperson asked why this activity was still being hosted. Mr. Michaud said he was curious as to why other clubs were "still doing them because [it's] not on their license[s] either". Commissioner Koutoulas stated that this event had been advertised on Facebook and that clubs could not advertise their events to the public. The director said he understood and that it would not happen again. He said he was going to speak to the person in charge of advertising to ensure this did

not reoccur and that they would be let go if it did. Mr. Michaud then stated that the "only reason" they had applied last year for the amendment was to "include everything [they] were doing" on the license. He further claimed that the AMVETS club did this activity on Monday nights and Crescent Yacht Club did it on Friday nights. He explained that the Elk's Club did this event to raise funds to stay afloat but acknowledged the amendment application had been denied. Commissioner Koutoulas explained that action had not been taken against other clubs as no such events had been brought to the Commission's attention, while this one had been publicly advertised. The Commissioner asked if Clerk Flynn could send out an advisory to all other clubs and told the director that his club was not being singled out intentionally. Chairperson Angus further underlined the issue with the club advertising to the public. Mr. Michaud said that the Facebook page was for members and guests only but Commissioner Koutoulas remarked that Clerk Flynn was nonetheless able to access the event information and print it out. The Chairperson added that she also saw this on Facebook despite not being a member and that future announcements needed to be clear that all events are for members and guests of members only. Mr. Michaud asked if this meant he could advertise as long as it was written that it was "members and guests only". Chairperson Angus stated he could not advertise any event as open to the public. Commissioner Koutoulas inquired if prizes could be advertised and the Chairperson said she did not think so. The director said he would "make it simple for everybody" and just delete the events off the Facebook page so he would not have to "come back". Commissioner Koutoulas clarified that the Commission would likely not approve this particular activity for any other business, based on advice from the Police Department. Mr. Michaud said he was only trying to "put down things that [they] had been doing for the last 20 years". The Commissioner once more underscored the importance of the club not publicly advertising, as required by law. The director said he understood.

Motion: Commissioner Koutoulas motions to place the matter on file.

Second: Chairperson Angus seconded.

Vote: 2 yeas, 0 nays, 1 absent, motion passed.

Mr. Michaud asked if he could have a conversation with the Commission after the meeting concluded. Chairperson Angus agreed.
