Sgt Lynch spoke for HPD. 6 pack sold to underage customers. At that time, clerk stated he knew nothing about TIPS.

Atty Bryan Aleward spoke for owner. Stated there is a system to scan license. Clerk did not ask customer for license (clerk is Sanjay Lama). Inderpal Gill, owner, explained ID scanning process.

Comm Angus recommended employees not use the override button and are compelled to scan ID.

Chairman Edwards recommends bringing in outside trainee company.

Sunil Samtani, appeared. He stated there is a 45 day provisional period when hiring employee in which time to be TIP certified. Employee had only been there 2 weeks. Sunil stated he was getting new cash register software- within 6 weeks. He has spoken to the employees and assured LLA this would not happen again.

Ankit Patel, owner, appeared for business. He stated he provides yearly training for employees. He is planning on obtaining the scanning software requiring scan of buyer's ID at every purchase. His employee/clerk at time of incident, George Charshoodian, appeared. He admits his mistake -Chairman Edwards stated that even if you personally know the person, you still need to ask for an ID. Chairman Edwards recommends that Ankit check out camera records to make sure clerks are asking everyone for their IDs.

Motion by Comm Angus to place business on **probation for 1 year and close for the next 2 consecutive weekends at 9PM – dates July 8 & 9 and July 12& 16**. If there is a violation within the year, they will be brought to LLA for further action.

The manager who was involved in the incident was new and had been in training for over days. This was her first shift working alone. Employee did not have TIPS as still new. Irene stated the cameras were not functioning at time of incident- if they are unable to repair, they will get a new system from ADP. Russ Littlefield spoke – has had business for 39 years. Comm Angus recommends that *he have 2 people working every evening*. Motion by Comm Driscoll to place business on **probation for 3 months**. Comm Angus seconded, no public comment. Vote unanimous.
