MAYOR FIORENTINI GAVE THE BACKGROUND ON THE BLOOMBERG MAYORS CHALLENGE. LAST U.S. CHALLENGE WAS IN 2013 AND WON BY PROVIDENCE, RI. THE MAYOR HAS IDENTIFIED GANGS AS A PRIORITY FOCUS. CITY HAS TO FIND INNOVATION SOLUTIONS TO THE PROBLEM OF GANGS.HAVERHILL WAS ONE OF THE FIRST 300 CITIES TO APPLY AND QUALIFIED FOR AN IDEA ACCELERATOR WORKSHOP WHICH WAS HELD LAST WEEK. NOAH KORETZ REVIEWED THE POWER POINT PRESENTATION. 35 CITIES WILL BE SELECTED FOR UP TO \$100K TO TEST IDEAS & BUILD LOCAL SUPPORT. 5 CITIES WITH BEST IDEAS WILL RECEIVE MILLIONS IN GRANT MONEY FOR IMPLEMENTATION. APPLICATION IS DUE OCT. 20<sup>TH</sup>. THE MAYOR WILL HAVE FOCUS GROUPS. COUNCILLORS SUGGESTED STAKEHOLDERS TO INCLUDE\*
