CHAPTER 240

An Ordinance Relating to Vehicles and Traffic

Be it Ordained by the City Council of the City of Haverhill that the Code of the City of Haverhill, Chapter 240, §108. Schedule: Central Business District Parking Fees, Rates and Terms, as amended, is hereby further amended as follows:

By adding the following at the end of the section "NOTES: \*\*Permit parking.....".

"The residents of 1 Water Street shall be considered residents of the Central Business District solely for the purposes of purchasing parking permits for use of the Herbert H. Goecke, Jr Parking Deck." (see document for complete text)

## Document 24

ORDERED: That \$990,000 is appropriated to pay costs of the construction of restoring and stabilizing the Merrimack Riverbank along the parking area behind the stadium, including the payment of all costs incidental and related thereto, and that to meet this appropriation, the City Treasurer, with the approval of the Mayor, is authorized to borrow said amount under and pursuant to Chapter 44, Section 7(1) of the General Laws, or pursuant to any other enabling authority, and to issue bonds or notes of the City therefor. (see document for complete text) Related communication from Robert Ward, Deputy DPW Director. Mr. Ward informed that the project includes restoring approximately 750' of riverbank along the parking area behind the stadium at Riverside Park. It is mandated as part of the Environmental Protection Agency Consent Decree issued by Department of Justice. There will be selective tree cutting and restoring from river to top of slope with rip rap. The increase in wastewater rate equates to \$4.00 per year.

Mr. Ward informed that this project is mandated as part of the Environmental Protection Agency Consent Decree issued by Department of Justice. All outflows were inspected. There was a high bacteria count in this area.*

- 2. <u>Document 120-Z/2017</u> Communication from Councillor Bevilacqua requesting to discuss State Cannabis Panel actions regarding recreational marijuana guidelines. *The Committee recommended: 1) sending a letter to Mayor asking engineering dept. in conjunction with Planning Director to plot and map locations where "package stores" sales are allowed; 2) have the City Solicitor draft ordinance accepting the local sales tax option to collect a 3% tax on sale of marijuana; 3) schedule regular meetings of the Administration & Finance Committee to further discuss these and other related issues; next scheduled meeting will be March 22*
- 3. <u>Document 7</u> Communication from Council President Michitson requesting to establish City Council goals for Haverhill in 2018-2020; *President Michitson informed that the Mayor will do a pilot program to set city goals and standards with some departments and will incorporate into city budget. Letter to Mayor to include draft of Haverhill Goals & Key Performance Indicators*
