**Investment Consultant Review & Update Report- 10AM**

- Overview of Markets and Performance Report
- Manager meetings for February

1. Wainwright Investment Council (WIC) provided a market update as of January 6, 2026, and discussed its performance through November 2025. David Van Dam indicated that Haverhill Retirement System (HRS) would take \$2M from Pension Reserves Investment Trust (PRIT) to cover benefit payments.
2. Wainwright Investment Council (WIC) provided a rebalancing report as of January 6, 2026 and updated the year-to-date net distributions from partnerships through the same period.

3. Wainwright Investment Council (WIC) provided preliminary performance for Putnam Investments and Fisher Investments as of December 30, 2025.
4. Wainwright Investment Council (WIC) presented a summary of all the partnerships as of September 30, 2025.
5. Fisher Investments, Boston Partners (Small Cap Value) and Columbia Threadneedle presented to the Board as finalist to the U.S. Small Cap Value search. Next meeting WIC will provide details on fees (commingled vehicles and performance base fee).

The administrator will bring this item up for discussion at a future board meeting.

- Board stipend discussion-

MGL, Chapter 32, Section 20-(6) *Retirement Board Members Compensation*. — The elected and appointed members of a city, town, county, regional, district or authority retirement board upon the acceptance of the appropriate legislative body shall receive a stipend; provided, however, that the stipend shall not be less than \$3,000 per year and not more than \$4,500 per year; provided, further, that the stipend shall be paid from funds under the control of the board as shall be determined by the commission; and provided, further, that an ex-officio member of a city, town, county, district or authority retirement board upon the acceptance of the appropriate legislative body shall receive a stipend of not more than \$4,500 per year in the aggregate for services rendered in the active administration of the retirement system.

After a brief discussion, a motion was made by MacDonald to increase the board stipends from \$3,000.00 a year to \$4,500.00 a year, seconded by Carr. The process will be reviewed by the administrator and a report will be given at the February 10, 2026 board meeting.


