THE MAYOR'S BRIEF BUDGET MESSAGE HIGHLIGTED SCHOOL BUDGET INCREASE OF \$5M A 6.3% INCREASE; HE WILL NOT SUPPORT AN OVERRIDE. POLICE BUDGET WILL ADD A NEW POLICE LIEUTENANT WHO WILL BE IN CHARGE OF NEW GANG UNIT. THIS IS TOP BUDGET PRIORITY. WILL ALSO FORM PARTNERSHIP WITH UTEC TO BE ANNOUNCED NEXT WEEK. MS. BETSY GOODRICH, MERRIMACK VALLEY PLANNING COMMISSION, GAVE AN OVERVIEW OF THE COMPLETE STREET PROGRAM. COMPLETE STREETS ARE DESIGNED AND IMPLEMENTED TO CREATE AN INTEGRATED NETWORK OF SAFE AND ACCESSIBLE TRANSPORTATION CORRIDORS THAT CONSIDER USERS OF ALL AGES, ABILITIES AND INCOME LEVELS AND IN ALL WAYS. THE MAYOR INTENDS TO FILE THE APPLICATION BY JUNE 1<sup>ST</sup> TO BE APPROVED AND SCORED BY THE STATE. IF APPROVED, CITY WOULD BE ELIGIBLE FOR UP TO \$400,000 PER YEAR IN STATE FUNDING FOR CONSTRUCTION & INFRASTRUCTURE PROJECTS THAT SUPPORT COMPLETE STREETS GOALS AND POLICY.
