- 5. COMMUNICATIONS FROM THE MAYOR:
  - 5.1.Mayor Fiorentini requests to give an update on Haverhill's efforts regarding the Coronavirus (COVID-19 crisis) postponed from November 16
    Mayor updates that the city's new Public Health Department has three new employees, an administrative assistant, a nurse, and a social worker. Public Health Dept. given task to address the two crises, opioid and the pandemic.
  - 5.2. Mayor Fiorentini requests along with our new Public Health Director, Mary Connolly to update the Council on our new Health Department and its goals and objectives. Mary Connolly. New public health nurse starting after the first of the year. A social/outreach worker will start in about two weeks, and an administrative assistant who already started. Hoping outreach worker and nurse will work with other communities to address the opioid crisis. No plan in place currently. Doing best to get people vaccinated with weekly clinics. The State will be bringing in clinics, December 13<sup>th</sup> and pop-up clinics throughout the town and Lawrence. Shipping issues seems to be the issue.
  - 5.3. Mayor Fiorentini requests to address Council concerning the RFP for the downtown parcels and to introduce members of our advisory committee to advise the Council on their preference for the preferred developer. Also, the preferred developer and their team will be here to present their proposal for the redevelopment of downtown Haverhill/Merrimack Street which consists of 5 parcels of City-owned land between Merrimack st and Bailey blvd 83-F

Councillor Bevilacqua recused himself from the meeting.

Mayor Fiorentini addressed the council. Stated the basis of this started many years ago when commissioned a plan by Utile of the redevelopment of Merrimack Street area. Issued an



RFP for the 5 lots downtown. The goals included finding a developer to replace outdated Goecke deck; reverse errors of urban renewal; and have a transformative development. Appointed an advisory committee comprised of planners, architects, department heads, Councillors, and Utile.

Bill Pillsbury stated five very strong responses were received. All different proposals which created opportunity for committee to evaluate based on conditions of the RFP and marketplace in Haverhill. The process generated questions for each developer to answer and be reviewed by the committee.

Council President Barrett and Councillor Daly O'Brien commented that Lupoli's plan is best possible use of space, had a plan and timeline to best suit the city; the change that we need, the next real step to help the bottleneck of Merrimack Street.

Richard MacDonald, Director of Inspectional Services and Committee member spoke of his positive experience working with the Lupoli Companies. Stated this was clearly the superior developer and project will be a success.

Gerry-Lynn Darci presented Lupoli's proposal. The proposal includes demolition of the Goecke parking deck and replacing it with a 616-space parking garage, 51K sq. ft. of street level retail space, small restaurants, and 370 residential units in five separate buildings.

Councillor Sullivan requested the "Goecke" name remain as part of the new development. Councillors Jordan and LePage questioned the effectiveness of the new garage. Jordan stated he would not support the project without increased staffing fire, police and schools.

Bill Pillsbury confirmed the Home Occupation section states you can have a limited number of employees, not students. It needs to have a language change.

Councillor Macek suggested not sending to committee but sending a letter to Solicitor Cox to provide a draft ordinance with new language to expedite. Pillsbury states must also go before Planning Board if a zoning change.

David Boucher, National Grid. To be clear and reiterate the correct work request number that we are proposing is 30478084 and that is the one we are petitioning for. That has the correct map, the initial one was not what we wanted to present to you. The one that is one this will show Research Drive and it has the correct information on it. Several weeks ago, I was before you asking for temporary polls which is in process right now. I am here tonight for a permanent way we would like to service the business on Research Drive, #51 Research Drive. That would be to go underground from our existing manhole 1 in the drawing as you see in the public way approximately 180 feet in the public way then gradually going into the right side of the driveway go up into the property to a switch gear. We are looking for two 5-inch conduits encased in concrete to have the rights to have them in that public way as shown in the diagram. If the City sees fit, it enables us to continue on our way to get them electricity in a permanent way.
