Councillor Barrett stated was part of the Hope Task Force and funding was never there. Asked if Coordinator would work also with Drug Free Grant which is a funding source for continuation. Asked if youth risk survey would be useful; is program exclusive to Haverhill residents specifically the adults needing assistance.

Ms. Boisselle stated Coordinator would work with grant writer that was hired by Mayor. Would like to work with schools and program mostly would be for Haverhill residents but wouldn't turn anyone away.

Councillor Sullivan asked if it is a one-year contract or multiyear, would like to know. Ms. Boisselle stated she did not know but would like a multiyear contract the paperwork has not been signed yet.

Council Vice President Michitson asked about the Drug Free Community grant status for obtaining a full-time coordinator to oversee the entire area? Asked that Chief of Staff check on the reimbursement to school for YMCA and recovery high school.

Mary Connolly stated you need HOPE Task in order to go for Drug Free grant so parttime coordinator for HOPE Task would be tasked for both; need one year of notes from meetings before applying for Drug Free.

Councillor Bevilacqua stated how important it is to be critically involved with our school systems. Thinking of the fact that the City Council approved five marijuana shops in the city. Point of Order by Councillor McGonagle who stated the citizens voted to have them in the city limits and the City Council did what the citizens voted for them to do and what the state mandated them to do to create these zones.

Councillor Bevilacqua said one of the issues is how critically important the schools will be but wonders if should begin earlier than age of 12. Thanked for the presentation.

Councillor McGonagle feels there is not enough money and afraid a one-year program with nothing tied on the other end leads to uncertainty.

Councillor Lewandowski agrees wish there was more money. This is exact type of organization and model needed for the community. All home-based services which will impact families.

Vice President Michitson wanted an update on funding that is left from the Mayor's office and planning for the future since this is only a one-year contract. Would like the Council to receive an update on long term.

Councillor Rogers also agrees the money should be more, hard for someone to commit without certainty.

Councillor Toohey stated data is critical and proposal says, "outcomes will be negotiated with the city of Haverhill", has this been done or has it already been negotiated? Ms. Boisselle stated some of the outcomes are in the proposal that will be using, can change if people want something different.

President Jordan very happy moving forward on this. Do share concerns of other Councillors including salary for coordinator of \$60K and is it the going rate? Ms. Boisselle stated it will be difficult to find someone at that salary.

President Jordan asked the Chief of Staff to include with Vice President Michitson's request to work with the Mayor to identify different revenue sources, the impact money, and local option tax.

Christine Lindberg stated the funding sources are extremely fluid and do not have a set revenue stream. Recently notified by the State that there are additional settlements, but do not know what. The initial prospect of this was seed money to get this off the ground, to see what we could do with the money that we have; understand what the implications are, what we can do, what the costs will be so we can then move forward with the program. If it is not sustainable by cannabis impact fee or opioid settlement fees, then if it's a priority by the public see as to whether or not funding through operating budget. Looking at all options. Hard to commit funds when we don't know what they are going to be.

President Jordan said the local option tax doesn't show any indication of dropping off. Christine Lindberg agreed, and money goes right to the general fund then would have to be appropriated out of general fund into the operating fund and reallocate. President Jordan understands and that is why several Councillors wanted funds not to go into general operating fund but to a specific account. Also stated having a debt exclusion will have funds so as not to have an either-or situation.

Councillor Rogers asked if money not used what happens? President Jordan stated it goes to free cash.

#### President Jordan reopened the hearing from last week.

Attorney Paul Magliocchetti appeared before the Council. Thanked the Council for patience explaining wanted to go through the proper boards and to make sure all the neighbors had proper notice. Zoning and Planning Boards approved the plan last week. The final phase is to have the Council declare that the roads are formally discontinued. TJ Melvin of Millennium Engineering drafted the plan and is present to answer any questions.

TJ Melvin, Millennium Engineering, stated went through process of obtaining the variance and frontage waiver for property. Essentially it will allow to make the lot buildable by utilizing both of the two rights-of-way. Preliminary discussed the project with City Departments over nine months. Part of the project will include drainage at the corner of Hannah and Willow. The water flows through the property to the rear wetland and will work with engineering department to resolve any issues.

President Jordan asked if anyone would like to speak in favor? No one spoke. President Jordan asked if anyone would like to speak in opposition? No one spoke. President Jordan closed the hearing.

Solicitor Cox stated he has two orders before Council seeking to take two parcels that are located within the downtown area, which the Council previously voted to sell to the Lupoli Company, take them out of land registration and they would become ordinary recorded lots. Reason being, it is a very large parcel and the owners would like one parcel of land recorded in the same place where they can one plan and one deed. It is more of a matter of convenience, there is no issue with these lots in terms of title. The Title examiner has reviewed and certified that the City holds good title with regards to those particular lots.

13.3. Order of Taking – Brandy Brow Road, D & D Realty Trust; 14 parcels of land for water supply protection purposes

Related communication from William Cox Jr., City Solicitor

Solicitor Cox stated with last week's Council approval of the bond to create the funding source for the purchase of these parcels, before you tonight is the order for the purchase of 36.8 acres on Brandy Brow Road, 14 parcels for water protection purchases. The appraisal and evaluation of the land development cost is included in your package. This is a friendly taking which means we have been in discussion with the property owner. Mass General Law and City Charter prohibits us from purchasing a property that exceeds 125% of assessed value in last three years. It is more important to protect water resource areas and that is why we pursued this way.

15.1. Council President Jordan and Councillor Lewandowski seek a Council vote on a proposed rule change; under "Regular Meetings Rule 2" Eliminate the following sentence from Rule 2: "Additionally, in any year that the Mayor should choose to deliver his/her State of the City address on a Tuesday night at 7:00 P.M., the City Council meeting scheduled for that week shall be appropriately cancelled in advance"

President Jordan stated he did some research when this rule change went into effect. Concern with this rule is that it is poorly worded and effectively, based on what a previous Council voted in, allows the mayor, whoever he or she may be, to effectively unilaterally cancel a City Council meeting so the State of the City address can be given. We received recent communication from the Mayor asking to give his State of the City on a Tuesday at 7 PM. I offered two alternative dates that we don't have Council

meetings, he has elected not to go with those dates. Today's communication states he will be doing his speech on March 21, 2023 at 7 PM.

Spoke with Solicitor Cox today and the way the rule I worded, effectively Mayor can cancel a Council meeting. My request is to eliminate that one line.

Councillor Bevilacqua feels the way it should be done is to have the Mayor speak first then have the regular meeting. The appropriate action would be to send to A&F for recommendations that then would proceed from there.

Councillor Sullivan has similar thoughts on protocol and traditions and like the idea of the Mayor giving speech in front of the Council, it shows unity and respect. See no reason why the Mayor can come and have his speech at 6 pm and Council meeting at 7 which would be a reasonable compromise. Also do not have a problem with him having it at 7 and meeting after. It is a curiosity to let him give his address in front of us and the people while we are here.

Councillor Barrett remembers why the rule was added, remember that evening at Hunking School sitting in fifth grader chairs, bad lighting, and a long meeting. Similarly to Councillor Sullivan, I am fine with sitting in presence of the Council unless we have a production problem and need the day for a heavy duty special permit influx and not fair to those who come before us to wait. I am not eager to change the rule.

Councillor McGonagle looks at it that the Mayor had two other options and decided he didn't want those. There is no reason why the Mayor cannot choose another night that is not a Council night. Council will still attend it; it is a choice. Don't have problem giving power back to the President of the Council.

Councillor Lewandowski stated there are options and that will be vetted out at A&F. Removing the sentence really comes down to a matter of civility and cooperation and avoiding disruption to the regular course of business. Eliminating the sentence along with getting options from A&F will foster more cooperation between the Council and Mayor.

Councillor Barrett stated if doesn't pass she will make a motion to send to A&F, second Councillor Sullivan

President Jordan confirmed there is a motion on the table at this time.

Council Vice President states consequently should vote yes on motion and has not heard one city Councillor say they want to continue with this language going forward.

Councillor Sullivan reiterated that he came up with a compromise that the Mayor could speak on March 21 at 6:00 PM and we could have our meeting at 7:00 PM. That would be a way to compromise on this issue and show civility.

Councillor Bevilacqua received some communication from visually impaired citizen requesting the City develop a better system for crossing and that there be more automated and accessible street crossing around the city. In additional they ask that the crosswalks be better protected by red lights as the cars are not yielding to pedestrians. *Move that this be sent to DPW, City Engineer and appropriate departments to implement.* 

Councillor Sullivan agrees this is a recurring theme, talking about it more often. There are a lot of dangerous sidewalks, pedestrian crossings on major roads in the city. We need to take a better look at this and come up with a better more comprehensive plan to take care of this problem all over the city.

Christine Lindberg stated the city applied for and received a planning grant through the MVPC and there is the Safe Streets For All Federal grant also working on. Now working on implementation of grant. We are cataloging all intersections, sidewalks, street lights, etc. to make sure when we apply for these grants, we are incorporating all of those needs into those grant applications.
