Bassam Geha appeared on this application. He did not have the required green cards from the mailing. Abutters Eric Spohr, Lawrence Robeau and Scott Quinney all appeared at the meeting and stated that they had received the letter and signed the green cards. Commissioner Coco inquired why this application was being presented. Mr. Geha stated that he was told that the patios were included in the original application and found out after the last meeting that they were not so he has now applied for the alteration of premises. There was discussion about this establishment being in a residential neighborhood, the layout and safety of the patios and issues with alcohol and other items in the parking lot. Abutter Eric Spohr spoke in opposition to the application stating issues with noise and alcohol outside the premises. He stated that they already use the patios for alcohol. He presented photos and a letter to the Commission which he read into the record. Abutter Lawrence Robeau has no issue with them using the patio outside the restaurant, but would not like to see alcohol on the patio outside the function hall. It isn't really a patio – it is part of the entrance. They do not do a good job monitoring the function hall. He picks up a lot of trash in his yard from the restaurant. Abutter Scott Quinney spoke in favor of the application. The restaurant has been a great neighbor. Most of what the other neighbors are referring to happens after hours and outside the control of the restaurant. They close at 9-9:30. He has never had a problem with the noise. Mr. Geha indicated the restaurant has never had any violations. The family watches over the business and cleans the parking lot. Chairman Edwards indicted that Mr. Geha should place signs in the establishment stating no alcohol beyond this point to help curb the drinking outside. The Commissioners had comments and question regarding the pictures, cleaning the parking lot, the fact that this is a mostly residential neighborhood, working together with the neighbors to resolve these issues and signage on the property to help prevent things happening in the parking lot. Motion to postpone this item to a special meeting on or about June 4th or 5th made by Commissioner Coco, seconded by Chairman Edwards. Vote two yeas, one abstain, motion passed.

Sharon Cohen, manager, appeared on this matter. Captain Stephen Doherty of the Haverhill Police Department summarized the incident and state that after investigation it was determined that all parties involved were at the Tap prior to the incident. No charges have been made at this time. The victim was bothering patrons inside the establishment prior to the incident outside the establishment. The establishment needs to know that early intervention is necessary in these circumstances. Sharon Cohen indicated that she viewed the video and did not see anything happening in the bar. Captain Doherty indicated that several of the witnesses said that the victim had been bothering people in the bar and the establishment should have been the one to call. Ms. Cohen stated that the establishment does call and will continue to call. Chairman Edwards stated that she should talk to her staff – if they see something they need to do something. Commissioner Coco inquired about cameras. Chairman Edwards asked Ms. Cohen to do the best to prevent this type of incident from happening in the future.
