President Barrett read the following statement: This meeting of the Haverhill City Council is being conducted remotely consistent with Governor Baker's Executive Order of March 12, 2020, due to the current State of Emergency in the Commonwealth due to the outbreak of the "COVID-19 Virus".

In order to mitigate the transmission of the COVID-19 Virus, we have been advised and directed by the Commonwealth to suspend public gatherings, and as such, the Governor's Order suspends the requirement of the Open Meeting Law to have all meetings in a publicly accessible *physical* location. Further, all members of public bodies are allowed and encouraged to participate remotely.

The Order, which you can find posted with agenda materials for this meeting allows public bodies to meet entirely remotely and live so long as reasonable public access is afforded so that the public can follow along with the deliberations of the meeting. This meeting will have public comment.

Due to the ongoing COVID-19 Pandemic, Governor Baker issued an Emergency Order temporarily suspending certain provisions of the Open Meeting Law, G.L. c. 30A sec. 18. Public bodies otherwise governed by the OML are temporarily relieved from the requirement that meetings be held in public places, open and physically accessible to the public, so long as measures are taken to ensure public access to the bodies' deliberations "through adequate, alternative means."

HEARING OPENED

ATTORNEY ROBERT HARB INFORMED THAT HE WAS REPRESENTING MAZRANNY CONSTRUCTION AND THAT JOHN SAVA, THE ARCHITECT, WAS IN ATTENDANCE WITH MR. MAZRANNY AND OTHER PRINCIPLES OF MAZRANNY CONSTRUCTION. THIS PROJECT WILL PRESERVE A 100-YEAR-OLD BUILDING. IT WAS BUILT AROUND 1920. IT WAS A FORMER FUNERAL HOME. THEY PLAN ON CONVERTING THE EXISTING HOME TO TWO UNITS AND CONVERT THE EXISTING GARAGE BY RAISING THE ROOF TO MAKE A THIRD UNIT. THEY WILL LEAVE THE GREEN SPACE ON THE RIGHT. THERE IS AN EXISTING CURB CUT /DRIVEWAY ON THE LEFT. TO THE LEFT OF THE PROPERTY THERE ARE OTHER 3 FAMILY HOMES. THE PARKING REQUIRES 5 SPACES AND THEY WILL PROVIDE 7. FOUR ON THE SIDE AND THREE IN THE BACK WITH A PERGOLA. THE DEPARTMENTS ARE IN FAVOR AND WILL MEET THE SPRINKLER REQUESTS FROM THE FIRE DEPARTMENT. THERE WILL BE NEW ENERGY EFFICIENT SYSTEMS.

MR. SAVA INFORMED THEY WILL MAINTAIN THE LOOK OF THE BUILDING BUT WILL CHANGE THE COLOR. THE ROOF IS IN GOOD SHAPE. THEY WILL BRING SPRINKLER SYSTEM INTO THE HOUSE. THERE IS AN EXISTING CURB CUT TO THE LEFT. THERE WILL BE ADDITIONAL PLANTINGS ON THE LEFT. HE DISTRIBUTED PHOTOS OF THE EXISTING LOT*. NO ONE SPOKE IN FAVOR. MS CORRINE BOUTIN WAS OPPOSED. SHE QUESTIONED GREEN SPACE, CONSTRUCTION TIMELINE, NOISE AND TRAFFIC. ATTORNEY HARB INFORMED THEY WILL KEEP THE GRASS AS IS. IT WOULD TAKE APPROXIMATELY 3 MONTHS TO COMPLETE THE PROJECT, IF APPROVED. WORK WILL START AT 9AM AND FINISH BY 3/4PM. THEY TAKE NEIGHBORS INTO CONSIDERATION. IF THE HOME CONTINUED TO BE USED AS A FUNERAL HOME, IT WOULD GENERATE MORE TRAFFIC.

Councillor Sullivan presented the minutes and recommendation of the Natural Resources and Public Property Committee meeting that was held October 7 2020 regarding the Hannah Duston Monument in the Grand Army of the Republic (GAR) Park.

COUNCILLOR SULLIVAN READ THE MINUTES INTO THE RECORD AND MOTIONED TO HAVE THE MINUTES ACCEPTED AND PLACED ON FILE. HE INFORMED THAT THIS WAS THE FIRST OF TWO MEETINGS TO DISCUSS THE FUTURE OF THE HANNAH DUSTON STATUE CURRENTLY LOCATED AT G.A.R. PARK. THE SECOND MEETING WOULD FOCUS ON A RECOMMENDATION TO THE MAYOR.

Councillor Sullivan presented the minutes and recommendations of the Natural Resources and Public Property Committee meeting that was held on November 5 2020 regarding the Hannah Duston Monument in GAR Park.

The Committee motioned to recommend to City Council that the statue remain where it is in GAR Park and also, the City provide the Abenaki an opportunity to erect their own Memorial, with the City to provide land and site work in GAR Park.

COUNCILLOR SULLIVAN READ THE MINUTES INTO THE RECORD AND MOTIONED TO HAVE THE MINUTES ACCEPTED AND PLACED ON FILE. Yeas 9, Nays 0

Councillor Sullivan also read the minutes and recommendations into the record from the November 18 2020 meeting of the Haverhill Historic Commission. Councillors felt that the statue should remain in G.A.R. Park and offered the following recommendations to the Mayor: Paint a two-sided mural on the bandshell of prominent Native Americans; remove/cover the objectionable language (savages) at the base of the statue; remove the hatchet from her hand; develop a QR code type information source for a broader telling of the story at the base. Mr. Dan Speers spoke and asked the Council to remove the statue to another location. ON MOTION OF COUNCILLOR SULLIVAN WITH SECOND FROM COUNCILLOR DALY O'BRIEN TO SEND LETTER TO MAYOR RECOMMENDING THAT THE STATUE REMAIN WHERE IT IS IN G.A.R. PARK AND ALSO, THE CITY PROVIDE THE ABENAKI AN OPPORTUNITY TO ERECT THEIR OWN MEMORIAL, WITH THE CITY TO PROVIDE LAND AND SITE WORK IN G.A.R. PARK. ALSO, TO REMOVE THE OBJECTIONABLE LANGUAGE AT THE BASE OF THE STATUE. Yeas 9, Nays 0 56C
