ITEM FOR DISCUSSION: OUI LAST SERVED LIST FROM ATTORNEY GENERAL'S OFFICE

Sharon Cohen appeared on this matter. Chairman Edwards inquired how many times The Tap has been on this list. They have appeared six times since 2014. Ms. Cohen state they have all TIPS certified people and they are trained well. There are some things that happen that are beyond their control. Commissioner Sewell inquired if she knew the person on the list. Ms. Cohen stated that they do get notified and that she looked the person up and they only had two drinks. Commissioner Carter asked if they had people at the door and who is responsible for checking the door. Ms. Cohen stated that they have security people who check IDs and sobriety. Commissioner Sewell indicated that he did not like this method used by the Attorney General's office, as it can be used for a retribution situation. Commissioner Carter stated that this item is a reminder to continue their safety measures. Chairman Edwards stated that the Court does ask this question with every conviction. The establishment should be aware of people bringing in nips and the people on the deck. Ms. Cohen stated they have security and cameras on the deck. Commissioner Sewell indicated it could be a gage if there are multiple listings in a period.
