

City of Haverhill City Council Minutes Tuesday, July 14, 2020 Virtual Meeting

Present – President Barrett, Councillors LePage, Bevilacqua, Michitson, Sullivan, Jordan, McGonagle, Daly O'Brien and Macek.

City Clerk – Linda L. Koutoulas

President Barrett, Vice President LePage and City Clerk Koutoulas participated from the City Council office.

President Barrett read the following statement: This meeting of the Haverhill City Council is being conducted remotely consistent with Governor Baker's Executive Order of March 12, 2020, due to the current State of Emergency in the Commonwealth due to the outbreak of the "COVID-19 Virus".

In order to mitigate the transmission of the COVID-19 Virus, we have been advised and directed by the Commonwealth to suspend public gatherings, and as such, the Governor's Order suspends the requirement of the Open Meeting Law to have all meetings in a publicly accessible *physical* location. Further, all members of public bodies are allowed and encouraged to participate remotely.

The Order, which you can find posted with agenda materials for this meeting allows public bodies to meet entirely remotely so long as reasonable public access is afforded so that the public can follow along with the deliberations of the meeting.

Ensuring public access does not ensure public participation unless such participation is required by law. This meeting will feature public comment.

Due to the ongoing COVID-19 Pandemic, Governor Baker issued an Emergency Order temporarily suspending certain provisions of the Open Meeting Law, G.L. c. 30A sec. 20. Public bodies otherwise governed by the OML are temporarily relieved from the requirement that meetings be held in public places, open and physically accessible to the public, so long as measures are taken to ensure public access to the bodies' deliberations "through adequate, alternative means."

- **5.** Communications from the Mayor:

Communication was received from Mayor Fiorentini regarding the condition of two of our reserve fire trucks. The Mayor and Fire Chief Laliberty have been working on possible solutions. The Mayor will have a proposal as soon as possible and recommends that we wait until we have the up to date revenue numbers from the state and also recommends that we go forward with the bond order for the one new truck while we explore other options

MAYOR FIORENTINI INFORMED THAT HE THOUGHT THE BOND ORDER WAS BEFORE COUNCIL THIS EVENING FOR A VOTE. CLERK KOUTOULAS CLARIFIED THAT ADVERTISING FOR THE BOND DID NOT MAKE THE NEWSPAPER DEADLINE BECAUSE OF THE HOLIDAY AND WILL BE ON THE JULY 28 AGENDA.

THE MAYOR TOLD THE COUNCIL HE WILL WORK WITH THEM. HE DOES NOT WANT TO PAY CASH FOR THE FIRE TRUCKS. THE PAYMENT OF \$1M IN CASH LAYSOFF 20 FULL TIME EMPLOYEES. COUNCILLORS URGED HIM TO CONSIDER BONDING FOR 2 NEW FIRETRUCKS; BUYING A REHABBED/REFURNISHED TRUCK IS NOT ADVANTAGEOUS TO THE CITY BASED ON PRIOR EXPERIENCE. HE WILL LOOK INTO THE POSSIBILITY OF PAYING A PORTION OF THE COST FROM CDBG FUNDS BUT THAT ACTION WOULD REQUIRE HUD APPROVAL. THE MAYOR STATED HE WOULD HAVE AN AMENDED CAPITAL PLAN TO THE COUNCIL BY LABOR DAY.

Communication was received from Mayor Fiorentini to address Council along with City Auditor, Charles Benevento regarding payments being made to City by Haverhill Heights and also to address our demand and collection policies

MR. WILLIAM PILLSBURY, PLANNING DIRECTOR, INFORMED OF HIS CONVERSATION WITH SAL LUPOLI, DEVELOPER OF THE HAVERHILL HEIGHTS PROJECT, REGARDING THE TWO PAST DUE ANNUAL INSTALLMENT PAYMENTS TOTALLING \$225,333,34 FOR LAND PURCHASED FROM THE CITY. THE JUNE 15 2019 PAYMENT OF \$112,666,67 WAS MADE ON JULY 10 2020. MR. LUPOLI WILL PAY 1/3 OF THE \$112,666.67 AMOUNT DUE FOR THE NEXT 3 FRIDAYS IN JULY.

MAYOR FIORENTINI INFORMED THAT THE CITY WAS NEVER AT RISK OF LOSING ITS MONEY ON THE PROJECT AND THAT HE TAKES COMPLETE RESPONSIBILTY SINCE AN INVOICE WAS NOT SENT TO MR. LUPOLI. IN THE FUTURE, ALL CONTRACTS WILL BE ONLINE AND THERE WILL BE A 5% LATE CHARGE.

MR. BENEVENTO, CITY AUDITOR, INFORMED THAT THEY HAVE REVIEWED THE INTERNAL POLICIES TO ENSURE TIMELY PAYMENTS. PROCEDURES AREN'T NEW BUT THEY WILL BE FORMALIZED. HE REVIEWED THE DETAILS WITH COUNCIL. MR. BENEVENTO WILL ALSO CHECK TO SEE IF OTHER PROJECTS/DEVELOPERS OWE PAYMENTS TO CITY.

Communication from Council President Barrett, Councillors LePage, Michitson, Jordan, McGonagle, and Macek requesting that Mayor Fiorentini submit an Order for an appropriation of \$1,023,722.00 in the operational budget for FY2021, for the purpose of acquiring two new fire trucks which are deemed necessary by the Council, but are not included in the annual budget as presented. This request is being made under the Power of Council, as provided in M.G.L., Chapter 44, Sections 33. Power of Council to add to appropriation; conditions; limitations.

SOLICITOR COX EXPLAINED THAT THE ABOVE MGL CHAPTER 44, SECTION 33 HAS TO BE READ WITH SECTION 32. THE BUDGET SUBMITTED BY THE MAYOR PROVIDES FOR FIRE SERVICES, AS WELL AS THE MAINTENANCE, PURCHASE AND PAYMENT OF DEBT FOR FIRE TRUCKS. COUNCIL CAN ONLY ADD AN ITEM TO THE BUDGET IF THE MAYOR'S BUDGET FAILS TO PROVIDE FOR THE OBJECT OF THE APPROPRIATION. THIS HAS BEEN DETERMINED

BY CASE LAW. SOLICITOR COX CITED FLOOD V. HODGES A 1918 SUPREME JUDICIAL COURT DECISION.
