<u>CONTINUATION OF SHOW CAUSE HEARING FROM JUNE 4 2020 – ALLEGED VIOLATION – FAILURE OF</u> <u>COMPLIANCE CHECK – JUNK TRAILER STORED ON PREMISES, NOT COMPLYING WITH PARKING PLAN</u>

SGT KEVIN LYNCH APPEARED FOR THE HAVERHILL POLICE DEPARTMENT. HE INSPECTED THE LOCATION AND TRAILER WAS NOT REMOVED BY DATE REQUIRED BY LICENSE COMMISSION. ALSO NOT COMPLYING WITH FLOOR PLAN.

JEAN PIERRE SALIBA APPEARED FOR ROYAL CREST. HE STATED HE HAD CONTACTED SEVERAL COMPANIED TO REMOVE TRAILER BUT NO ONE WOULD TAKE UNLESS VEHICLE BROKEN DOWN INTO 5 PIECES(NOT TOWABLE).

COMM CARTER QUESTIONED WHY HE SIS NOT CONTACT THE CLERK OR THE POLICE TO EXPLAIN THE SITUATION.

MR SALIBA STATED HE IS WORKING ON THE ISSUE AND IS HAVING DIFFICULTY AND THAT HE IS TAKING APART THE TRAILER WITH HIS EMPLOYEES AND IT IS NOT DONE TODAY. HE SHOWED PHOTOS OF HIS PROGRESS.

Comm Edwards spoke to Mr Saliba and told him to get removal done and follow plot plan. He is inclined to suspend license till remedied.

MR SALIBA DIVERTED CUSTOMER PARKING TO WHERE THEY USED TO PARK (UNTIL TRAILER IS REMOVED). THIS IS A VIOLATION OF THE RECENT APPROVED PARKING PLAN PER COMM CARTER, AS WELL AS THE NON REMOVAL OF TRAILER. COMM CARTER MADE MOTION TO SUSPEND LICENSE FOR 2 WEEKS OR UNTIL MATTER IS RESOLVED, WHICH EVER IS LATER.

IF IN COMPLIANCE AND IS CONFIRMED BY HPD, HE CAN RECEIVE HIS LICENSE BACK

MOTION BY COMMISSIONER CARTER TO SUSPEND LICENSE, SECONDED BY CHAIRMAN EDWARDS, NO PUBLIC COMMENT. VOTE 2 YEAS, ONE ABSENT.
