William Pillsbury, Economic Development Director, addressed the council. This evening, we are requesting approval of the annual resolution for our Community Development Block Grant (CDBG) Program. As an entitlement community, we receive federal funding each year and are required to submit a detailed plan outlining how those funds will be used. Despite delays at the federal level, we have finalized this year's plan, which reflects a modest 3.3% increase in funding. However, strict regulations limit only 15% of the funds for public services—such as food pantries, heating assistance, and homelessness prevention—despite increasing demand. The majority of the funding will continue to support housing rehabilitation, code enforcement, and public improvements in low- and moderate-income neighborhoods, as 80% of funds must benefit these populations. We've identified 26 programs for funding this year, and while we've prioritized sustaining critical services, we are also planning cautiously for potential federal cuts in the future. Approval of this resolution will allow us to submit all required documentation and move forward with program implementation.

During the discussion councilors raised concerns about the \$15,000 allocated to first time homebuyer program, asking whether any of the funding is used. William Pillsbury responded that usage had been minimal due to strict income limits. It was asked if unused funds could be put in the Housing Trust Fund. William Pillsbury stated the funds don't disappear; any reallocation would need to comply with CDBG regulations. It was noted by the council that if they lose CDBG funding the food banks would suffer.

Councilor Lewandowski addressed the council. She noted she has been discussing Bill 3660 with Representative Vargas which would allow Massachusetts cities to adopt a vacancy tax on residential units left unoccupied for a set period, with exemptions for valid cases like renovations or medical issues. The goal is to encourage occupancy, increase housing availability, and generate revenue for affordable housing. Even without state approval, municipalities could pursue local versions through a ballot initiative. This could be a valuable tool to support housing efforts and should be considered for further review by subcommittee.

Planning Director William Pillsbury stated from a planning perspective, if we consider using tax revenue for a trust, that money would need to go through the usual appropriation process. He noted it is worth considering especially in the context of the looming federal cuts.

Councilor Lewandowski also noted the need for a multifaceted approach to addressing commercial vacancy and revitalizing downtown areas. She highlighted the potential value of the Massachusetts vacant storefront program. A state initiative that offers up to \$50,000 on refundable tax credits to businesses that occupy long vacant storefronts. The program requires municipalities to apply through Community One Stop for Growth portal.

Motion by Councilor Lewandowski to refer the local option vacancy tax on residential properties as well as a second look at the MVSP relative to commercial to the Planning and Development Subcommittee for further review. Second by Vice President Jordan.

Councilor Michitson and Vice President Jordan thanked Councilor Lewandowski for bringing this forward. They noted both proposals are worth exploring.

15.2. Communication from Councillor Michitson requesting to address Haverhill's affordability housing issue and upward mobility gaps 33-M

Councilor Michitson noted at the recent Planning and Development Committee meeting, members discussed the city's housing production plan and its link to Haverhill's growing upward mobility crisis. With 52% of renters and 28% of homeowners cost-burdened, and low-income student rates rising (56% in high school, 69% in kindergarten), concern was raised about long-term impacts. A focus was recommended on workforce development, quality education, and inclusive schools—key pillars of upward mobility. Whittier Tech's proposed 200-seat expansion was deemed insufficient given high demand, with roughly 800 students annually missing out on vocational education. A cross-sector career training and awareness initiative was proposed, involving Haverhill High, Whittier Tech, NECC, nonprofits, businesses, and state programs. Additional recommendations included better funding, access to MassHire, and employer incentives.

Motion by Councilor Michitson to send to Planning and Development Subcommittee meeting to get feedback on cross-cutting career training event from various participants. Second, Vice President Jordan.

Vice President Jordan voiced concerns that vocational education is too limited, even with the added seats, Haverhill students may lose out with the lottery system. We need the state support to expand programs and ensure more local kids get the opportunities they need. Councilor Lewandowski noted MakeIT Haverhill is having a job fair, it is great that we can bring these jobs to young people. Councilor McGonagle noted not enough money from the state.

Motion by Councilor McGonagle to send a letter to the delegation to go to the governor and get us the money to help our kids, get us the money to help Whittier Vo-Tech open up the number of students they can take.

City Clerk Wright stated I think by Robert's Rules you need to make that motion first. You need a second.

President Sullivan stated we didn't get a second.
