- 1. Wainwright Investment Counsel provided a market update as of February 2, 2021 and a preliminary performance update for the portfolio as of December 31, 2020.
- 2. Wainwright Investment Counsel provided a rebalancing report as of February 2, 2021. Wainwright Investment Counsel reminded the client that the valuations used for rebalancing purposes are the most recent valuations available from People's United Bank and that those valuations will be different from the valuations ultimately reported by Pension Reserves Investment Trust (PRIT).
