Christine Webb explained during the early stages of the billing setup process for FY22, it was discovered after the assessment classification report was refreshed that Haverhill realized some additional real estate and personal property value which was not known about during the Tax Classification hearing on November 16, 2021. We are required by the DOR to present a brief Tax Classification hearing demonstrating the changes that that represents. You will be asked this evening to vote again on the six separate items (PowerPoint presentation shown).

Councillor Bevilacqua made motion to take 1 million free cash to reduce the levy obligation, Councillor McGonagle seconded motion. President Barrett stated hearing was still open. Councillor McGonagle asked Councillor Bevilacqua how much that would be. Councillor Bevilacqua did not know with new numbers presented.

Christine Webb stated with new values presented this evening it would reduce residential rate by 3 cents or \$12 per average tax bill, approximately \$500K savings from November 16th hearing.

Michael Stankovich gave description of ARP plan. In terms of available funding, Haverhill is anticipating receiving approximately \$38 million in two allotments. First has been received already (approx. \$18M) the balance anticipated to be received June 2022. Extension reporting due quarterly and annually; US Treasury looks at all information and determines approvals on all spending; Documents go four years after the end period which is December 2026. We setup protocols and outside council to help and will also work with the State Administrative & Finance Department. Will be retiring in January but staying on part-time

to manager along with the infrastructure money. Those funds can be used for infrastructure,
