HEARING OPENED

ATTORNEY ROBERT HARB REPRESENTED THE APPLICANT. CHRIS CRUMP AND JOHN SABA OF SABA ARCHITECTS, JAMES ALLEN, WILLARD WALKER, AND WILLIAM PILLSBURY, ECONOMIC DEVELEOPMENT AND PLANNING DIRECTOR ALL SPOKE IN FAVOR. THIS IS THE FIRST PROJECT UNDER THE NEW WATERFRONT OVERLAY DISTRICT. THERE WILL BE 40 UNITS, 26 TWO BEDROOMS AND 14 ONE BEDROOMS IN 5 BUILDINGS. MAJORITY OF PARKING WILL BE UNDERNEATH BUILDING. ALL PARKING WILL BE ON SITE. WHEN THE PROJECT IS COMPLETED MR. ALLEN WILL RESIDE THERE. MR. ALLEN PURCHASED EASEMENT TO RAIL TRAIL IN BACK OF THIS PROJECT AND WILL ALSO CONTRIBUTE \$60,000 TO CITY TOWARDS RAIL TRAIL IMPROVEMENTS UPON ISSUANCE OF 20TH OCCUPANCY PERMIT. THE AFFORDABILITY REQUIREMENT IS NOT APPLICABLE SINCE THE CITY IS OVER 10%. HEARING CLOSED.
