CHAPTER160

An Ordinance Relating to Graffiti

Be it Ordained by the City Council of the City of Haverhill that the Code of the City of Haverhill, as amended, is hereby further amended by adding the following as Chapter 160: §160-1 Purpose and scope.

The purpose of this Ordinance is to help prevent the spread of graffiti vandalism and to establish a program for the removal of graffiti from public and private property. The City of Haverhill considers graffiti a public nuisance and destructive of the rights and values of property owners as well as the entire community. Unless graffiti is removed from public and private property, the graffiti tends to remain Neighboring properties then become the target of graffiti, and entire neighborhood are affected and become less desirable places in which to be, all to the detriment of the City of Haverhill.

§160-2 Public nuisance; Duty of owner or person in possession.

- A. The existence of graffiti on public and private property in violation of this ordinance is expressly declared to be a public nuisance and, therefore, is subject to removal and abatement provisions specified in this ordinance.
- B. B. It is the duty of the owner of the property in which the graffiti has been applied and any person who may be in possession or who has the right to possess such property at all times to keep the property free and clear of graffiti.

CHAPTER 83

An Ordinance Relating to Revolving Funds

Be it Ordained by the City Council of the City of Haverhill that the Code of the City of Haverhill, Chapter 83 is hereby added as follows:

"Chapter 83. Revolving Funds

§83-1. Purpose. This ordinance establishes and authorizes revolving funds for use by city departments, boards, committees, agencies or officers in connection with the operation of programs or activities that generate fees, charges or other receipts to support all or some of the expenses of those programs or activities. These revolving funds are established under and governed by General Laws Chapter 44, § 53E1/2.

§83-2. Expenditure Limitations. A department or agency head, board, committee or officer may incur liabilities against and spend monies from a revolving fund established and authorized by this ordinance without appropriation subject to the following limitations: (see document for complete text)
