# City Council Minutes

President Barrett read the following statement: This meeting of the Haverhill City Council is being conducted remotely consistent with Governor Baker's Executive Order of March 12, 2020, due to the current State of Emergency in the Commonwealth due to the outbreak of the "COVID-19 Virus".

In order to mitigate the transmission of the COVID-19 Virus, we have been advised and directed by the Commonwealth to suspend public gatherings, and as such, the Governor's Order suspends the requirement of the Open Meeting Law to have all meetings in a publicly accessible physical location. Further, all members of public bodies are allowed and encouraged to participate remotely.

The Order, which you can find posted with agenda materials for this meeting allows public bodies to meet entirely remotely and live so long as reasonable public access is afforded so that the public can follow along with the deliberations of the meeting. This meeting will have hybrid – in person, virtual and call-in.

Due to the ongoing COVID-19 Pandemic, Governor Baker issued an Emergency Order temporarily suspending certain provisions of the Open Meeting Law, G.L. c. 30A sec. 20. Public bodies otherwise governed by the OML are temporarily relieved from the requirement that meetings be held in public places, open and physically accessible to the public, so long as measures are taken to ensure public access to the bodies' deliberations "through adequate, alternative means."

## Councillor McGonagle recused himself and left the Chambers

## PRESIDENT BARRETT OPENED THE HEARING

ATTORNEY MIGLIORI REPRESENTED FROSTY NUG, HAVERHILL LLC REQUESTING A SPECIAL PERMIT TO OPERATE AN ADULT USE MARIJUANA ESTABLISHMENT AT 1181 BOSTON ROAD. HE INTRODUCED JACK HUDSON, CHAIRMAN OF FROSTY NUG, PRINCIPLES MIKE GETTINGS, DR. KRISTYN PISTONE, AND DR. DOMINICK GARIBALDI. TEAM MEMBERS BRIAN BELTS, BRENDAN KAVANAUGH, SCOTT THORNTON, STEVEN STAPINSKI AND MATT JUROS. EACH PERSON SPOKE ABOUT THEIR AREA OF EXPERTISE EXCEPT FOR BRIAN BELTS, WHO WAS NOT AVAILABLE.

THE LOCATION OF THE LME (LICENSED MARIJJUANA ESTABLISMENT) IS FIRST CHOICE AUTO. THE FOOTPRINT OF THE BUILDING WILL REMAIN THE SAME. THERE ARE 2 DRIVEWAYS, ONE WILL BE CLOSED. THE TRAFFIC COUNTS WERE DONE IN JANUARY AND FEBRUARY OF 2020. THERE WILL BE NO LEFT TURN WHEN EXITING THE SITE. THERE WILL BE 22 PARKING SPACES ON SITE FOR CUSTOMERS. EMPLOYEE PARKING WILL BE OFF-SITE WITH A REMOTE SITE TO BE DETERMINED. THEY PROPOSE 4 CUSTOMERS PER 15 MINUTES FOR 2/3 WEEKS BY APPOINTMENT ONLY. THERE WILL START WITH 5 POINTS OF SALE BUT WILL HAVE ROOM FOR 8. WILL HAVE STATE OF THE ART SURVEILLANCE SYSTEM WITH 24/7 VIDEO SURVEILLANCE, ON SITE SECURITY AND USE OF A SECURE SALLYPORT. THERE WILL BE NO ON-SITE CONSUMPTION. 3% OF GROSS SALES WILL BENEFIT THE CITY AND 3% TOWARDS LOCAL OPTION TAX. \$25K WILL BE CONTRIBUTED TO LOCAL CHARITY CHOSEN BY THE CITY.

JOY SMITH SPOKE IN SUPPORT. BARBARA DANEAU HAD A QUESTION ABOUT TRAFFIC. THOSE SPEAKING AGAINST/OPPOSED WERE LESLEY HILTON, JONATHAN CAMPBELL, PRESIDENT OF FARRWOOD GREEN 2 CONDO ASSOCIATION ON BEHALF OF ALL 6 OTHER CONDO IN THE FARRWOOD DRIVE COMPLEX EXCEPT FOR ONE INDIVIDUAL. THEY VOICED THEIR STRONG OPPOSITION DUE TO TRAFFIC AND SAFETY CONCERNS. HE CITED ACCIDENTS AND THE FACT THAT THERE IS A BLIND CURVE ACCESSING THE SITE ON 4 LANE HIGHWAY. SITE IS LOCATED BETWEEN 2 RESIDENTIAL HOMES. SHERRY DIANGILIS STATED SHE LIVES DIRECTLY BEHIND THE SITE WHICH IS A RESIDENTIAL NEIGHBORHOOD WITH NO SIDEWALKS THAT IS HEAVILY USED BY WALKERS, KIDS RIDING BIKES AND SCOOTERS. IT IS ALSO A CUT THRU FROM FERRY ROAD TO CROSS ROAD. GEORGIA SIMMS SPOKE ABOUT TRAFFIC AND THE ON LINE PETITION THAT WAS SUBMITTED TO CITY COUNCIL OPPOSED TO THE SITING OF FROSTY NUG AT THIS LOCATION. IF CUSTOMERS CAN'T TURN LEFT WHEN EXITING THE SITE THEY WILL END UP TAKING A LEFT INTO FARRWOOD DRIVE OR BRADFORD STREET TO TURN AROUND.

SCOTT THORNTON OF VANASSE ASSOCIATES INFORMED THAT THE BLIND CURVE WILL BE ADDRESSED IN THE FUTURE THAT WILL INCREASE THE LIGHT OF SIGHT AND THEY DID INCLUDE THE AMAZON TRAFFIC IN THEIR STUDY. HEARING CLOSED.

COUNCILLOR SULLLIVAN MOTIONED TO APPROVE THE SPECIAL PERMIT WITH A SECOND FROM COUNCILLOR DALY O'BRIEN.

COUNCILLORS EXPRESSED THEIR GRAVE CONCERNS ABOUT SAFETY AND EXISTING TRAFFIC ON RTE. 125, PROPOSED TRAFFIC AND QUESTIONED THE ABILITY TO ENSURE THAT CUSTOMERS WOULD NOT TAKE A LEFT HAND TURN OUT OF THE SITE. THEY REFERENCED CITY ENGINEER'S CONCERN ABOUT THE TRAFFIC. THE LACK OF 18 FEET RIGHT OF WAY WIDTH ACCESS FOR FIRE APPARATUS IN BACK OF THE BUILDING. WETLANDS IN THE REAR AREA

DURING COUNCILLORS' DISCUSSION THE FOLLOWING CONDITIONS WERE STATED:

THERE WOULD BE NO LEFT-HAND TURN ONTO RTE. 125N; POLICE PRESENCE AT APPLICANT'S EXPENSE TO MONITOR FOR A PERIOD OF TIME; PRIVACY FENCE FOR NEIHGBORS WITH GOOD VISIBILITY AND CURBING AS REQUESTED; APPROPRIATE WIDTH FOR FIRE APPARATUS IN REAR; POLICE DEPARTMENT, FIRE DEPARTMENT AND CITY ENGINEER WILL BE IN CHARGE OF APPROVING ANY INCREASES IN APPOINTMENTS AND WILL HAVE RIGHT TO REDUCE AS THEY SEE FIT BUT NO LOWER THAN ORIGINAL APPOINTMENT SCHEDULE. MASS DOT WILL HAVE TO REDESIGN CREATING A LEFT TURNING LANE ON RTE. 125N.

ON MOTION OF COUNCILLOR SULLIVAN TO AMEND THE MOTION TO INCLUDE ABOVE CONDITIONS WITH SECOND FROM COUNCILLOR DALY O'BRIEN.

Communication from Councillor Mary Ellen Daly O'Brien requesting a discussion regarding Trick or Treat

COUNCILLOR DALY O'BRIEN EXPRESSED HER CONCERNS ABOUT THE CITY MOVING FORWARD WITH TRICK-OR-TREAT AND URGED THE MAYOR TO RECONSIDER THE DECISION. SHE REFERRED TO THE CDC'S COVID-19 CAUTION ABOUT HOLIDAY CELEBRATIONS.\* VARIOUS SUGGESTIONS/ALTERNATIVES WERE MADE TO THE MAYOR. THE MAYOR INFORMED THAT THE BOARD OF HEALTH WILL HAVE AN EMERGENCY MEETING THIS THURSDAY ON TRICK-OR-TREAT. HIS BOTTOM LINE IS TO KEEP THE CITY SAFE. ON MOTION OF COUNCILLOR DALY O'BRIEN TO SEND A LETTER TO THE MAYOR WITH CDC BULLETIN.

Communication from Councillors Michitson and Jordan requesting an update from Mayor Fiorentini on COVID-19 status in Haverhill

COUNCILLOR MICHITSON QUESTIONED THE MAYOR ABOUT PROCEDURES/PROCESS IF WE HIT THE RED ZONE.

MAYOR FIORENTINI INFORMED THAT WE ARE IN THE RED ZONE. IN THE PAST 2 WEEKS THERE HAVE BEEN 150 COVID CASES AND 120 OF THEM ARE ACTIVE. LARGE PART OF IT IS DUE TO LAKEVIEW NURSING HOME - 58 CASES AND 18 FROM A HOUSE OF WORKSHIP THAT IS NO LONGER HAVING SERVICES. HE DOESN'T WANT TO SHUT DOWN BUSINESSES AND HAS ASKED THE STATE TO RAMP UP TESTING. THERE WILL BE FREE MOLECULAR TESTNG AT 2 DRIVE UP OR WALK IN SITES STARTING SEPTEMBER 30 THRU OCTOBER 14. THE MAYOR ADDED THAT THEY WILL RAMP UP A MEDIA CAMPAIGN. PUBLIC SERVICE ANNOUNCEMENTS

WILL BE IN SPANISH AND ENGLISH. WE HAVE ENTERED INTO A PARTNERSHIP WITH PMA TO PROVIDE TESTING FOR STUDENTS AND TEACHERS. THE CITY IS LOOKING TO HIRE A BILINGUAL PERSON TO ASSIST WITH CONTACT TRACING. DR. MADDOX SPOKE ABOUT THE PROCESS FOR QUARANTINING AND THAT SCHOOLS WOULD REMAIN OPEN UNLESS WE ARE IN THE RED ZONE FOR 3 CONSECUTIVE WEEKS.

The parcel is located entirely within the watershed of Millvale Reservoir, which supplies up to 70+ percent of the City of Haverhill's drinking water. (see document for complete text)

ON MOTION OF COUNCILLOR BEVILACQUA THAT WITHIN 2 HOURS AFTER A SEWERAGE DISCHARGE OCCURS A ROBO CALL AND OTHER MEANS OF PUBLIC NOTICE IS PROVIDED TO THE CITIZENRY OF HAVERHILL
