THE CLERK STATED 2 BEER & WINE LICENSES WERE AVAILABLE AS THE APPROVED APPLICANT HAD SURRENDERED THE PREVIOUSLY ISSUED LICENSE THE WEEK PRIOR. THE CLERK INFORMED THE COMMISSION AN APPLICANT WOULD BE HEARD DURING THE MAY MEETING IN REGARD TO ONE OF THE AVAILABLE LICENSES.
