It would cost \$1M to demolish building. They do not have any plans or funds at this point to do anything with the building. It will remain as is. They have spent millions of dollars on campus improvements.

Hearing was opened on <u>Document 84 - Petition</u> from City of Haverhill requesting Street Alteration — to take a portion of Bellevue av and add it to Hillside av with a Conditional favorable recommendation from Planning Board and Director. City Engineer John Pettis represented the city. He informed that there is an existing retaining wall (20 feet) down the middle of a portion of Bellevue Avenue that causes confusion. This matter was reviewed by the Planning Board and no one objected to it. There are 3 homes in this section and the address would change to Hillside Avenue. Ms. Antoinette Metheny, 21 Bellevue Ave. strongly opposed the name change stating it would cause hardship for her and that no one parks along the wall. Mr. Pettis commented that there is on-going parking along the wall.

<u>Document 91 –</u> Petition from Attorney Paul Magliocchetti representing Ernest Cioto as trustee of Cioto Realty Trust for property at 38 Railroad st – submitting a proposal for Waterfront District Zoning (Subzone F) Mayor Site Plan Review to build 60 residential condos in 3 separate buildings built in phases; Comments received from various City Departments are included HEARING OPENED

Attorney Magliocchetti represented Ernest Cioto and introduced the team, John Sava, Architect, Chris Crump from CWB Design and Brian Murphy, Millennium Engineering. Attorney Magliocchetti explained that this project was filed under the Waterfront Zoning Ordinance and fits into the category By Right Site Plan. There is a density bonus and that 40 units can be built per acre. Chris Crump gave a PowerPoint presentation. This project is called Riverview Condominiums. There will be 3 buildings built in phases, 1 per year. One and two bedrooms only. The buildings will be 55 feet high. There have been talks with the City Solicitor regarding the rail trail. 100% off street parking with grade level and underneath parking. John Sava reviewed the design. The units will be tiered and connected by decks. All units will be sold at full market rate. The center of each building will have a glass atrium front to back. There will be 2 entrances to the property. Each building will have 10 one bedrooms and 10 two bedrooms. They plan on having docks for residents and for public use.

Attorney Magliocchetti informed that they are working cross easements with the City Solicitor. This is not a special permit.

No one from the audience spoke in favor. Those opposed were William Gould Jr, Sandra Odea, Dana Fields, Leslie Gould, Lisa Corr, Linda Fields and George Frascone. Their objections were height of buildings, excessive traffic and infrastructure can't handle associated motor vehicles, loss of privacy, headlights shining into home abutting project, size of project too big for location.

Attorney Magliocchetti answered questions from abutters about traffic study, marina, screening/buffering,

William Pillsbury, Economic & Development Planning Director, informed that the development of a minimaster plan was done by Harriman Associates and a sub-zone was put in place to redevelop properties. The intent is to bring the rail trail to river's edge all the way down to Groveland. The city owns the railbed and will pursue state grants for new roadways and that portion of rail trail will be constructed by this project. **HEARING CLOSED**
