-With Police and Fire Approval, Building Inspector condition of use must be same as previously approved, access to building must be clear and not blocked or reduced from the sale of cars, lot must have 1 handicap parking spot and 1 9x19 customer parking spot.

Eziddin Eljedr, applicant, was present. Chairperson Angus reminded the applicant that:

- The certificate of occupancy was still pending, and that no cars could be present on the new dealer's lot until this certificate was received and approved.
- Under Haverhill law, there cannot be anything within 5ft of the building to provide permanent access to emergency vehicles.
- They must reserve the area in the back of the lot for employees, customers, handicap parking, seasonal maintenance, and pre or post-sale cars. (approx. 10 spaces)

The Chairperson then asked about the applicant's experience in the business: the applicant answered they used to work at Drive And Thrive in Methuen for two years, and that they had worked in the business of buying, selling and shipping vehicles overseas since 2018. Chairperson Angus verified that the applicant would use a repair shop in Methuen MA, which the applicant confirmed. Commissioner Koutoulas reminded the applicant that all used cars must include the Lemon Law sticker in accordance with Massachusetts law. Chairperson Angus inquired if the applicant was aware of the logbook of sales the applicant was required to maintain, and the applicant replied he would have one in the office.

Motion: Commissioner Koutoulas motions to approve the application, pending the business occupancy certificate, subject to the approval of Police and Fire Approval, Building Inspector condition of use must be same as previously approved, access to building must be clear and not blocked or reduced from the sale of cars, lot must have 1 handicap parking spot and 1 9x19 customer parking spot.
