President Barrett read the following statement: This meeting of the Haverhill City Council is being conducted remotely consistent with Governor Baker's Executive Order of March 12, 2020, due to the current State of Emergency in the Commonwealth due to the outbreak of the "COVID-19 Virus".

In order to mitigate the transmission of the COVID-19 Virus, we have been advised and directed by the Commonwealth to suspend public gatherings, and as such, the Governor's Order suspends the requirement of the Open Meeting Law to have all meetings in a publicly accessible physical location. Further, all members of public bodies are allowed and encouraged to participate remotely.

The Order, which you can find posted with agenda materials for this meeting allows public bodies to meet entirely remotely and live so long as reasonable public access is afforded so that the public can follow along with the deliberations of the meeting. This meeting will have public comment.

Due to the ongoing COVID-19 Pandemic, Governor Baker issued an Emergency Order temporarily suspending certain provisions of the Open Meeting Law, G.L. c. 30A sec. 20. Public bodies otherwise governed by the OML are temporarily relieved from the requirement that meetings be held in public places, open and physically accessible to the public, so long as measures are taken to ensure public access to the bodies' deliberations "through adequate, alternative means."

Mayor Fiorentini requests to give an update on Haverhill's efforts regarding the Coronavirus (COVID-19) crisis along with Councillor Daly O'Brien

Mayor Fiorentini informed that we are coming up to the one year anniversary of the coronavirus pandemic, March 15, 2020 and that we will commemorate that day on Monday. We are still in the red zone. There was a holiday surge. In terms of the vaccine, there will be 2 additional vaccine clinics in Haverhill. The goal is to have everyone vaccinated by the end of summer and 75 % by July 4<sup>th</sup>. Vaccines will be given at the Citizens Center by the health department. Starting next week we will receive 600 doses a week. He thanked Mary Connollly and her team. These vaccines are for Haverhill residents 65+ with 2 or more underlying conditions. There is no link yet. They are working on a back log of 75 years and older. When the link is available it will be posted. The Mayor hopes to get a mobile unit out to Mt. Washington/acre area for those without transportation. The other clinic will be offered by Haverhill Family Health owned by Gr. Lawrence Family Health Clinic located in Central Plaza, next to Market Basket formerly Rite Aid. This will be open to anyone who lives or works in Haverhill or surrounding region. They are working on a link. Go to GLFHC.org to watch for announcement. He is working on a grand opening next week with the assistance of Rep. Vargas. Also, working on 1 or 2 Saturday clinics for teachers and support personnel. If you have a computer, sign up for notification when the vaccine is available at Haverhillrec.com. Call 978 374-2390 if you don't have a computer. Trinity Ambulance will be giving vaccines at Haverhill housing properties. PMA is notifying its patients directly. He encouraged the use of the state website for Mass vaccine site in Danvers. Councillor Daly O'Brien informed that the indoor capacity has changed and schools will start to reopen in April. CVS will receive 25,000 doses for teachers in the next 3 days. Sign up on the CVS app. PLACED ON FILE 5G
