Anthony Pepe, applicant and owner of Food Truck Festivals of America, was remotely present for this application. He explained they are an event marketing company that puts on food truck and craft beer festivals across the country. He stated it was a "family fun" event, and that they have never had alcohol-related issues during past events. He added that they have check-in security and that they use wristbands for patrons 21+, which are checked frequently. He expressed he would like to make this event annual in Haverhill.

Sgt. Kevin Lynch approached to speak on this application. He stated that he had spoken with someone in the applicant's party about the venue requiring a cordoned off area for

alcohol consumption. He added that, even if wristbands were used and repeatedly monitored, patrons could not walk around the venue as there would be "no control." He also said that police detail would be required. Mr. Pepe said they would follow all rules required and could set up a beer garden. Chairperson Angus said she was also going to inquire about the beer tents setup and how patrons would consume alcohol. The applicant replied they would create a beer garden "approved by everyone" and add it to their map, as well as request police detail and fire & health departments to do inspections to ensure the food trucks are safe.

Chairperson Angus remarked that the required Event Permit had been postponed twice by City Council due to an ongoing issue between the City's Inspectional Services Department and Kimball Farm, the event's location. The Chairperson suggested this application be tabled until the August 7th meeting and asked for the applicant to submit the revised site plan to the Clerk and Sgt. Lynch in the meantime, indicating the designated area for alcohol consumption. Mr. Pepe asked if there was anything they could do to resolve the issue in question – the Chairperson replied she believed it had to do with a matter on the farm itself but that it was between Inspectional Services and Kimball Farm.

Items 6.1 & 9.1 were heard together.

Ashley Holt, applicant, was present for these applications. She stated she had been looking at this location for a while and wanted to open a live music venue without any "rowdiness." Chairperson Angus inquired if the applicant was aware that any entertainment performers would count against her occupancy number, and Ms. Holt said she did. The Chairperson also asked that the Entertainment license ending hours be pushed back by half-an-hour to ensure that patrons leave the premises on time. Ms. Holt replied they were not trying to stay as late as their requested hours anyways, as they wished to limit public disturbances. Chairperson Angus then asked about her experience in the business and verified if she would be able to be present on the new premises 40+ hours a week – the applicant replied she had been with The Hidden Pig in Haverhill since it opened and that she would be present at least 40 hours a week at the new bar. Commissioner Driscoll asked that the applicant use security cameras – Chairperson Angus added that they need to have 30-day retention and to provide phone numbers for points of contact in the event of an incident. Ms. Holt agreed. Chairperson Angus noted that a couple of corrections needed to be made to the Liquor License application and asked that a motion be made pending these corrections.

The Chairperson then asked if they had received the abutters notification letters' signed green cards. The manager provided a copy of the relevant tracking information but they had not received any cards back as of then.

<u>-Item for Discussion: Entertainment License Violation – Unauthorized Drag Show hosted on or about June 7, 2025 at 4PM</u>

Phillip McCabe, manager, was present. Chairperson Angus said she understood the show was part of the City's Pride Parade. The manager confirmed so, explaining that they were approached to participate in a performance hosted at various locations and didn't realize the full scope of the event. He added that his business had nothing to do with organizing the event. Chairperson Angus inquired if performers actually danced or if they came in just to socialize – Mr. McCabe said they socialized and danced around but that it was not a true show. The Chairperson advised that the manager apply for an amendment to their Entertainment license if they wished to host drag shows again in the future. The manager replied he understood that any new changes to the license would require an amendment with the Commission's approval. Commissioner Driscoll noted that any such amendment would be a "one-time" change.

12.2 Sharon Cohen, Manager

<u>-Item for Discussion: Entertainment License Violation – Unauthorized Drag Show hosted on or about June 7, 2025 at 3PM</u>

Sharon Cohen, manager, and assistant manager Stephanie Dalton were present. Chairperson Angus asked if this was the same situation as with Bosa Restaurant. The manager replied she believed all required permits were covered by the event organizers – the Chairperson remarked that they had received a letter that morning from the event organizers indicating this same belief. She then said that it appeared to be a misunderstanding over whether the performers were performing on The Tap's premises or if they were just "traveling through." Ms. Cohen said they were told by the event organizers that the performers would just be mingling with their customers but that it did end up being a show. The manager added that she was proud that the City hosted the event and that, should the City host it again in the future, she would "certainly" add "Drag Show" to her Entertainment license. Chairperson Angus explained that the Commission simply wanted businesses to amend their licenses in advance of hosting activities they are not currently licensed for, citing G's in Haverhill as an example. Commissioner Driscoll reminded the manager that it would be a one-time, permanent change to the license. Ms. Cohen replied that there was no "Drag Show box" to check off – the Commission commented that they would look into updating the application.

City Councilor Devan Ferreira approached to speak on the event in question. She stated there had been a "pretty consistent confusion about this event and what the event permit covered". She said that the "checking boxes" process was confusing and that she does not see it as common practice in other nearby municipalities. She then said that there has been an increase in Drag Show-related performances in the City and that any clarification on the City ordinance or local regulations would be helpful, adding that she would be happy to work on this as City Councilor. The Councilor commented that "we could do without more confusion for our businesses downtown." Chairperson Angus replied that the Commission was not "there to stop

them" but that they just wanted to "keep everything across the board," referring to the fact that some businesses had already applied for an amendment in anticipation of planned events. The Councilor said that G's had hosted a separate drag show entirely on their premises on a different day, while the event organizers had had an event permit and believed this covered all requirements across the City. She then remarked that it can be confusing for entities to know which departments in City Hall need to be referred to when verifying full permit(s) requirements, and that her goal as City Councilor and City resident was to "streamline" this process. Commissioner Driscoll told the Councilor that he believed the difference between hosting a "story-time" at the library and a full drag show performance was that many businesses in question had a Liquor License, explaining the reason for checking off Entertainment option-boxes, but agreed that the process could be improved upon. Councilor Ferreira stated that she believed the whole City ordinance ought to be reworked so that there could be less confusion overall, such as with neighboring municipalities.
