ORTIZ SUGGESTED AS A WAY TO REDUCE TRAFFIC PROBLEM IN THE AREA, ESPECIALLY IN WINTER TIME, TO LOOK AT IDEA OF MAKING NICHOLS AND FRANKLIN STREETS ONE WAY GOING SOUTH TO NORTH AND MAKING CEDAR STREET ONE WAY NORTH TO SOUTH. ## **13.** Communications from Councillors

Communication was received from Councillor Macek requesting to introduce Superintendent James Scully to give an update on this year's school opening

Superintendent Scully's overview included this is his 8<sup>th</sup> year as superintendent; in 2010 student enrollment was 7,451 students and as of today, 8,136; athletic department increase in students participating in sports has grown to 1,200; in 2010 low income students were 42.4%, today 67%; the Greenleaf School was supposed to go off line. It's the School Committee decision to open or close it. The State said they would not give any funding for capital improvements there. Due to increasing population the school is being used. It's been clean and painted, roof leak has been rectified.

Hunking population is 1,024 today. Opening day traffic nightmare at Hunking adjustments have been made. Baseball field won't be ready until the spring. The soccer field is being used and dogs are not allowed. The MSBA is coming to Haverhill to look at Consentino issue. Haverhill High School has an I school. The School Department is stressing the positives about the school system and a new esprit de corps is noticed. He also noted the significant monetary contributions from Ernie DiBurro, the Fantini's, Dr. Maddox, business community and individuals.

Councillors comments included the leasing of St. Joseph's as an option, use of Greenleaf School - a solution has to be found for kindergarten as this is a one year solution, drop out issue needs to be addressed,  $21^{st}$  century technology needs to be made available at other schools, system-wide.
