Councilors Hobbs Everett, Ferreira, Michitson and Lewandowski discussed recent questions about water usage in relation to new development. It was noted that new developments may slightly increase water use, overall impact is minimal compared to weather fluctuations. New buildings are constructed with water saving fixtures. Concerns were raised low water levels and visible impact of drought like the beach at Kenoza Lake. The city follows a state approved drought management plan and residents can report concerns directly to the state.

Mayor Barrett addressed the council. She noted that they have held several meetings with representatives from the 11 communities. Through the meetings it has become clear that the choice is either to invest in extremely costly repairs to the current site or to develop a joint campus with Northern Essex Community College. We have come to a consensus that the joint campus at NECC is the way to go. In your packet you will find a letter representing the next step to move forward with the joint campus, and if all members do not sign, we will not be able to continue with the MSBA process at this time. She noted she will not sign if they are staying at the Vo-Tech and stated she has been up front with everyone about that. President Sullivan, Councilors Michitson, Toohey and Hobbs Everett discussed the need for skilled workers as many tradespeople are retiring. The discussion focused on the next steps, proposed lottery system, and the capacity of number of students in the new building. It was confirmed this was still in the early stages. Superintendent Lynch noted that 35% of Whittier Tech graduates go directly into the workforce. It was noted that the feasibility study is projected to cost \$2.5 million. Northern Essex and Whittier Tech each agreed to pay \$500,000. The study will propose 3-4 different models, and the hope is the cost may be reduced.
