An Ordinance Relating to Vehicles and Traffic

# MUNICIPAL ORDINANCE

**CHAPTER 222** 

An Ordinance Relating to Streets and Sidewalks

Be it Ordained by the City Council of the City of Haverhill that the Code of the City of Haverhill, Chapter 222, as amended, is hereby further amended by adding the following at the end of the said Chapter: "Article XIV Parklets

§222-84 Definitions

When used in this section, unless the context otherwise requires, the following term shall have the following meaning:

Parklets shall mean private seating platforms paid for by the applicant that convert curbside parking spaces into vibrant community spaces. Also known as street seats or curbside seating, parklets are the product of a partnership between the city and local businesses. Parklets should encourage pedestrian activity and neighbourhood interaction, and, crate a benefit for local businesses. Parklets prioritize people over automobiles facilitating the City's vision of a "walkable city", and, providing outdoor dining facilities without the need to permanently remove curbside parking

The Floodplain District is herein established as an overlay district. The District includes all special flood hazard areas within the City of Haverhill designated as Zones A and AE on the Essex County Flood Insurance Rate Map (FIRM) issued by the Federal Emergency Management Agency )FEMA) for the administration of the National Flood Insurance Program.
