Hearing was held on Document 114 – A communication from Christine Webb, City Tax Assessor, for Tax Classification Fiscal Year 2020 with related information and Orders. Ms. Webb gave a PowerPoint presentation. Ms. Webb informed that every Non-Evaluation year the Commonwealth requires all municipalities to perform a complete update of all real and personal property values based on the prior calendar year sales and overall market conditions. This year, FY 2020, Haverhill's residential class has increased in value at a greater rate than the Commercial, Industrial & Personal Property (C.P.I.) class. Speaking to the issue were Christine Webb, Steve Gullo, Chuck Benevento, Dougan Sherwood, Tom Granneman, Joanna Dix, Gabriella Vargas and Dale Leone.

Councillor Bevilacqua inquired about changing the tax classification for large apartment complexes to commercial instead of residential. Ms. Webb will look into it.
