MR. BUCUZZO GAVE AN UPDATE ABOUT THE SOLAR ARRAY FOR THE LANDFILL. NO VOTE WAS REQUIRED AT THIS TIME. IN SEPTEMBER 2017 RFP WAS ISSUED FOR SOLAR DEVELOPMENT. 8 FIRMS WERE SELECTED FOR REVIEW. IN NOVEMBER RECOMMENDATION WAS GIVEN TO MAYOR AND KEARSAGE ENERGY WAS SELECTED BECAUSE IT WAS MOST ADVANTAGEOUS TO CITY. MR. PACHECO, FORMER CITY ENERGY MANAGER, IS CONSULTING ON THIS PROJECT. COUNCILLORS STRESSED THE NEED FOR A DEDICATED PERSON FOR ENERGY RELATED PROJECTS BECAUSE CITY IS NOT ABLE TO TAKE ADVANTAGE OF NUMEROUS OPPORTUNITIES. PLACED ON FILE Yeas 9, Nays 0 12

MUNICIPAL ORDINANCE

CHAPTER 120

Be it Ordained by the City Council of the City of Haverhill that the Code of the City of Haverhill, Chapter 120, as amended, is hereby further amended by adding the following:

"§120-15: Residential Construction Signage

"All residential homes being constructed pursuant to a special permit and/or an approved subdivision shall erect a sign during construction which provides the following information: the name, address and telephone number (both regular and an emergency contact) for the construction company performing the work. The signage shall be a minimum of 18" x 24" and shall be visible from the street. The sign may be free standing or may be attached to the structure being erected. If the required information is already included on a sign for the Conservation Commission, no other posting is required."

CHAPTER 70

An Ordinance Relating to Officers and Employees

Be it Ordained by the City Council of the City of Haverhill that the Code of the City of Haverhill, Chapter 70, Article II, as amended, is hereby further amended by adding the following to the end of the section entitled "Reports to Council" in §70-21:

"The Auditor of Accounts shall file monthly with the City Council two separate reports, one a copy of the General Fund Operating Statement and one a copy of the Fund Balance Report, with both reports to be filed for the prior month period."

COUNCILLOR DALY O'BRIEN DESCRIBED THE SITUATION WHERE IN THE INNER CITY MANY LARGE HOMES HAVE NO OFF-STREET PARKING. SUGGESTED THAT IN SPECIFIC AREAS SUCH AS THE ACRE, HIGHLANDS, AVENUES & MT. WASHINGTON AREA, AFTER A SIGNIFICANT SNOW STORM CARS ARE MOVED TO THE OPPOSITE SIDE OF THE STREET WITHIN CERTAIN TIME PERIOD TO ALLOW FOR PLOWING.

Communication from Mayor Fiorentini regarding request from Rivers Edge Apartments to purchase parking permits for the Goecke Parking Deck and also submitting Ordinance relating to this request. MS. CHRISTINA TERELLI, PROPERTY MANAGER – RIVERS EDGE APARTMENTS, INFORMED THAT SHE SPOKE WITH LAZ PARKING AND WAS TOLD THAT THEY COULD NOT PURCHASE PARKING PERMITS BECAUSE THEIR BUILDING WAS NOT LOCATED IN THE DOWNTOWN BUSINESS DISTRICT. PROPERTY WAS PURCHASED BY ARROW POINT PROPERTES IN 2016. THEY HAVE 164 UNITS WITH 80 AVAILABLE PARKING SPACES. THE PROPERTY USED TO BE FOR ELDERLY HOUSING. OVERNIGHT PARKING IS PROBLEMATIC IN INCLEMENT WEATHER. NO OVERNIGHT PARKING IS ALLOWED AT MARKET BASKET PARKING LOT. MS. TERELLI STATED THEY WERE SEEKING 40 OR 20 PARKING PERMITS. DISCUSSIONS WITH MR. FRANZONE ABOUT PARKING ON HIS PROPERTY DID NOT WORK OUT. COUNCILLOR DALY O'BRIEN INFORMED THAT PARKING IN THE GOECKE PARKING GARAGE DOES NOT REQUIRE PARKING PERMIT FROM 8:00PM TO 8:00AM. COUNCILLOR BARRETT ADDED THAT THEY CAN USE PARKING METERS IF NEEDED. COUNCILLOR BEVILACOUA SUGGESTED USE OF BAILEY BOULEVARD AND CITY HALL PARKING LOT. MR.STANKOVICH, DIRECTOR, PUBLIC WORKS ANSWERED QUESTIONS.

MUNICIPAL ORDINANCE

CHAPTER 240

An Ordinance Relating to Vehicles and Traffic

Be it Ordained by the City Council of the City of Haverhill that the Code of the City of Haverhill, Chapter 240, §108. Schedule: Central Business District Parking Fees, Rates and Terms, as amended, is hereby further amended as follows:

By adding the following at the end of the section "NOTES: **Permit parking.....".

"The residents of 1 Water Street shall be considered residents of the Central Business District solely for the purposes of purchasing parking permits for use of the Herbert H. Goecke, Jr Parking Deck." (see document for complete text)
