THE UNITS IN THE PROPOSED NEW BUILDING HAS BEEN RECONFIGURED FROM 12 TWO BEDROOM UNITS TO 6 TWO BEDROOMS AND 6 STUDIOS. THIS PROJECT IS ESTIMATED TO COST \$8.9MILLION. FINANCING WILL BE FROM A FEDERAL TAX CREDIT PROGRAM AND HISTORIC CREDITS. OPPOSED WERE MICHAEL SCHROTH, MARIA DIMAKIS, THOMAS MCNEIL, REGGIE KING, AND LLOYD JENNINGS. MR.
