Anne Docosta and the Legion Commander appreared for this. HPD were called for a disturbance. They arrived and found a heavily intoxicated woman sitting in the parking lot crying. She said she was assualted by her boyfrind's sisters. She was taken to the hospital and HPD issued crimial complaint for A/B on 2 other females.

Anne Decosta spoke. She said that she was not there that night. Ms. Decosta said thre was a function there that night. The function ended between 10 and 10:30 pm. Ms. Decosta was not sure if the female victim went into the members section after the event or left and came back. Commissioner Edwards asked HPD if any of the officers witnessed the assault. HPD said that no officers witnessed the assault. HPD also said that they knew all 3 femals were at the American Legion because all three female said they were at the American Legion.

HPD and LLA said they were concernd about the overserving.

LLA advised Ms. Decosta they need to tighten things up. They had another recent event in November of possible over serving.

<u>Commissiner Driscoll made a motion to place this in the American legion file and take no furthur action. This was seconded by Commissioner Angus. No Public comment vote unanimous. Motion Passed.</u>

# 15.1 David Ginieres <u>DISCUSSION OF QUESTIONS AND CONCERNS ABOUT CLUB RULES AND</u> REGUATIONS

David Ginieres appeared. He is a member of the Kiwanis club. They hold events at different clubs in Haverhill. He had questions about the club rules. He said they have been holding events like this for a long time and does not understand why there are so many rules on club liquor licenses. He came into the clerks office last week and spoke with clerk (Jennifer) abut the advertising. She advised him it cannot advertise it open to the public. It must be advertised for members and guests of the Elk's club.

Mr. Ginieres also asked about the process of signing in guests. He said that it is not the usual practice of the rental club to provide the sign in book and sign in guests. He asked who is responsible to sign in the guests. LLA told him that the rental club is responsible to provide the sign in book and to sign in the guests. Also, the clubs have been spoken to about the sign in process and they are aware that this is the process.

Mr. Ginieres also asked about the liability of signing in guests. He questioned where the liability falls if there was incident to occur with a guest that someone signs in. The LLA told him that the person whom is serving the alcohol has most of the responsibility and the licensed premises also holds an insurance policy and they cannot give legal advice. He also asked if the guests needs to be signed in even if they are not drinking. The LLA told him yes, they need to be signed in even if they are not drinking.

Mr. Ginieres stated that he would like to stay informed of the process of the new club rules and regulatios that has been in the works. The LLA told him that he would get an invitation to the next meeting. The next meeting for the club rules is expected to take place in another two months and the rules and regulations are anticipated to be complete in early summer or late spring.
