President Michitson read the following: Because the City Council must approve appropriations/transfers from the stabilization account by the City's Charter and there is no other body that can perform this work, and because due to conflicts of interest a quorum (6 votes required) will not be available to act on the matter, the Rule of Necessity allows those who are conflicted to participate.

Councillor Sullivan explained the Rule of Necessity and invoked the Rule of Necessity, upon advice of the City Solicitor. He disclosed that he has a conflict of interest because he has a parking pass and he parks in the parking garage and that his business is located in the Merrimack Street Business District; Councillor McGonagle disclosed that he has a conflict of interest because he owns property at 100-102 Merrimack Street; Councillor Barrett disclosed that she has a conflict of interest because her family owns property on Merrimack Street; Councillor Bevilacqua disclosed that he has a conflict of interest because he is a director at Haverhill Bank which abuts the property in question and that his son works for Lupoli Companies and Mr. Lupoli is Chairman of the Merrimack Valley Chamber of Commerce Board of Directors.

The investment in the boardwalk extension for \$500,000 will yield approximately \$5million return; intangible benefits - 200 new jobs, new Culinary Arts Institute (NECC)*

A 10 STORY BUILDING, WITH RESTAURANTS, INCUBATOR SPACE, MARKET RATE HOUSING
WITH 42 LUXURY APARTMENTS. FLOORS 2-3 WILL HAVE A CULINARY SCHOOL & INCUBATOR
SPACE FOR SMALL ENTREPRENUERS; FLOORS 4-9 WILL HAVE LUXURY APARTMETNTS, THERE
WILL BE A ROOFTOP RESTAURANT/SKY LOUNGE SUPPORTED BY RESTAURANT BELOW. HE
ASKED THE CITY TO EXTEND THE BOARDWALK. HE WILL BE INVESTING MILLIONS OF

DOLLARS ON THIS PROJECT. HE ALSO PURCHASED THE BUILDING AT 131-133 MERRIMACK ST. THEY WILL USE PROPERTY FOR STAFF WHILE HAVERHILL HEIGHTS IS BEING BUILT AND THEN IT WILL BE TORN DOWN.

Director of Public Works, Michael K Stankovich submits Contract for solid waste & recycling services and representatives from MA DEP will be at the meeting to further explain environmental trends and what Mass communities can do to lessen their impacts

MR. STANKOVICH INTRODUCED BROOKE NASH, MASS DEPT BRANCH CHIEF, MUNICIPAL WASTE REDUCTION PROGRAM WHO GAVE A POWERPOINT PRESENTATION. SHE INFORMED THAT CHINA HAS IMPOSED HIGHER LEVELS ON CONTAMINATED PRODUCTS EFFECTIVE 1/1/2018. CHINA IS LARGEST IMPORTER OF RECOVERED PAPER AND PLASTICS IN THE WORLD. THE MILFORD, MA, GLASS PLANT CLOSED 3/30/18 WHICH WAS THE LARGEST CONSUMER OF RECYCLED GLASS IN THE NORTHEAST. CONTAMINATION IN RECYCLING INCREASES COSTS. ALL COMMUNITIES ARE SEEING RISE IN RECYCLING COSTS. MASS DEP IS LAUNCHING AN EDUCATIONAL EFFORT TO HAVE PEOPLE RECYCLE SMARTER. GRANT PROGRAMS ARE AVAILABLE THRU MASS DEP (RECYCLING IQ KIT) TO EDUCATE COMMUNITIES ABOUT RECYCLING WHICH INCLUDES REVIEW OF MATERIALS IN RECYCLE BINS TO REDUCE CONTAMINATION AND INCREASE SMARTER RECYCLING. OUR NEW RECYCLING/SOLID WASTE COORDINATOR, AMANDA BUCKLEY, WILL BE INVOLVED WITH THE OUTREACH EFFORT. PLACED ON FILE
