Matt Belfiore and Dave Shultz of HC Media addressed the council and presented a brief preview of a video about manufacturing jobs and usage of a recruitment tool. As cable revenues decline we are reinventing ourselves through community focused initiatives. The project in partnership with local manufacturers, NECC, the Chamber of Commerce, and Councilor Michitson is one of the first steps. President Sullivan opened the hearing.

Marcos Devers presented on behalf of the property owner a proposal to renovate and convert an existing two-family wood-frame dwelling, built circa 1910, into a three-family residence. The property, located on a 7,535.88 sq. ft. lot within an RU zoning district, was purchased in June 2022. The proposed project includes demolition and reconstruction of the rear interior section, the addition of a rear deck, and interior reconfiguration, all within what was described as the original footprint. The application triggered a special permit review due to the amount of demolition conducted, which exceeded what had been previously approved by the Zoning Board of Appeals.

President Sullivan asked if anyone would like to speak in favor. No one spoke. President Sullivan asked if anyone would like to speak in opposition. No one spoke. President Sullivan closed the hearing.

MOTION BY VICE PRESIDENT JORDAN TO APPROVE, SECOND BY COUNCILOR FERREIRA

Council discussion followed, led by Councilor Toohey, who raised concerns about the increase in square footage from 2,454.5 sq. ft. to 2,661.6 sq. ft. and the proposed increase in bedrooms from six to eight. He questioned whether this expansion violated the original footprint and expressed concern over density potentially occurring without full approvals. Marcos Devers acknowledged that construction had begun and extended beyond the initial permit due to unsafe structural conditions, but stated this had since been addressed with inspectional services. He expressed a willingness to amend the proposal to six bedrooms.

Councilors Basiliere and Rogers also supported reducing the number of bedrooms, citing safety, crowding, and code compliance, particularly the need for proper egress, sprinkler systems, and hardwired smoke and carbon monoxide detectors. Councilor Ferreira noted that the Zoning Board had already approved the conversion, and emphasized that issues related to interior layout and code compliance would be handled during the developmental review process. She supported the project as a way to add housing in a dense but well-connected area.
