# Councilor McGonagle recused himself and left the Chambers

#### **HEARING OPENED**

Attorney Migliori introduced Mr. Robert DeFazio, CEO and members of the team, Michael Allen - Chief of Security and Ken Cram - Traffic Consultant. Mr. DeFazio, CEO of CNA Stores gave his background and made PowerPoint presentation. He is a service-disabled veteran and intends to hire from veteran community. This will be a retail store and buying from Sanctuary Medicinals in Littleton. It will be appointment only with ordering on-line. 20 customers per hour. Parking is available in front, side and rear will be for employees. Exit will be out of the side. Delivery will come thru covered sally port. Security will be on site with uniformed police and police detail. Hours will be 10-8 Monday-Saturday and 12-6 on Sunday. Mr. Allen informed that positive ID verification is required. There will be sophisticated video surveillance and monitors in vestibule area. Mr. Cram addressed traffic study and mitigation plan with traffic volume summary of River St, east of Maxwell Street and discussion about Florence Ave. Traffic impact is insignificant in the location. Mr. DeFazio informed that 3% of gross sales will be given to city; they will make \$25K charitable contribution to local charity, Veterans Outreach and LUNGSTRONG. They will give 100 community hours. They will provide employment for veterans and Haverhill residents, about 15-20 employees and plan on using local vendors. Attorney Migliori informed that they have a signed Host Community Agreement. CNA intends to team up with Full Harvest Moonz regarding the school system issues of education. They comply with zoning ordinance Ch. 255-80 Sec. E and they have no objections to accepting the conditions as stated by departments. Melissa Cerasuolo spoke in favor. Those speaking against were Lynn Wedge, Catherine Mortimer, Terasema Brown, Deborah Elliott and Jessica Winiecki. **HEARING CLOSED**

# MUNICIPAL ORDINANCE An Ordinance Relating to Dogs and Other Animals

Be it Ordained by the City Council of the City of Haverhill that the Code of the City of Haverhill, Chapter 137, as amended, is hereby further amended as follows: By adding the following at the end of the Chapter:

"Article IX Animal Welfare

17-27 Confining an animal in a motor vehicle.

Any person owning, possessing or controlling an animal in the City of Haverhill shall not allow or permit said animal to be confined inside of a stationary or parked motor vehicle in a manner that would reasonably be expected to threaten the health of the animal due to exposure to extreme heat or cold. The process of removing an animal form a motor vehicle will be defined by M.G.L. c.140, § 174F. An initial violation of this subsection shall be punished by a fine of \$50.00, and, a second and subsequent offense shall be punished by a fine of \$300.00. Nothing in this subsection shall preclude prosecution under M.G.L. c.272, §77."
