Be it Ordained by the City Council of the City of Haverhill that Chapter 255, Table 1, TABLE OF USE AND PARKING REGULATIONS, being and is hereby further amended as follows:

Section 255, Zoning Table 1: In as much as (a Portion of) the remaining IG zone (Stevens Street-west side only (Little Rive Side) is an area in significant transition all uses except residential, mixed residential/commercial and performing arts in this portion of this IG zone (Stevens Street-west side only (Little River Side) where the table is currently "P" PERMITTED shall be changed in "S" – SPECIAL PERMIT by the City Council. All uses previously permitted (P) in the balance of the IG zone (particularly Hale Street) shall remain permitted uses.
