

City of Haverhill City Council Minutes Tuesday, February 2, 2021

Virtual

Present – President Barrett, Councillors LePage, Bevilacqua, Michitson, Sullivan, Jordan, McGonagle, Daly O'Brien and Macek.

President Barrett read the following statement: This meeting of the Haverhill City Council is being conducted remotely consistent with Governor Baker's Executive Order of March 12, 2020, due to the current State of Emergency in the Commonwealth due to the outbreak of the "COVID-19 Virus".

In order to mitigate the transmission of the COVID-19 Virus, we have been advised and directed by the Commonwealth to suspend public gatherings, and as such, the Governor's Order suspends the requirement of the Open Meeting Law to have all meetings in a publicly accessible *physical* location. Further, all members of public bodies are allowed and encouraged to participate remotely.

The Order, which you can find posted with agenda materials for this meeting allows public bodies to meet entirely remotely and live so long as reasonable public access is afforded so that the public can follow along with the deliberations of the meeting. This meeting will have public comment for the special permit hearing.

Due to the ongoing COVID-19 Pandemic, Governor Baker issued an Emergency Order temporarily suspending certain provisions of the Open Meeting Law, G.L. c. 30A sec. 20. Public bodies otherwise governed by the OML are temporarily relieved from the requirement that meetings be held in public places, open and physically accessible to the public, so long as measures are taken to ensure public access to the bodies' deliberations "through adequate, alternative means."

Mayor Fiorentini informed that the numbers are going down but that they are still too high. He expressed concern about Super Bowl parties and urged folks not to go outside their household to celebrate with others. Vaccine clinics for those 75 years and older starts this week. Sign ups for vaccine is frustrating. Walgreens in Bradford will have the vaccine. Trinity will be vaccinating those in senior housing. He explained the use of the state website for the vaccine and referenced the city's website. The toll free number – 211 – is available for scheduling appointments is available but there is a long wait. Mary Connolly, public health nurse, has hired 2 people to help with contact tracing. Councillor Daly O'Brien asked for patience.

Communication from Councillor Colin Lepage requesting to introduce Rocky Morrison of the Clean River Project to give a progress report on their clean-up efforts of the Merrimack River MR. ROCKY MORRISON INFORMED THAT THE CLEAN RIVER PROGRAM PULLED 20.61 TON OF DEBRIS FROM HAVERHILL IN 2020. HE GAVE A POWERPOINT PRESENTATION. THEY CLEANED UP 23 HOMELESSS CAMPS. THE CLEAN RIVER PROJECT RECEIVED A STATE MET GRANT FOR \$4,000. MR. MORRISON WOULD LIKE TO HAVE HIS CONTRACT EXTENDED SO THEY CAN TACKLE THE WORK THAT NEEDS TO BE DONE BEHIND RIVERSIDE PLAZA.

PRESIDENT BARRETT INFORMED THAT THE PUBLIC WOLD BE ABLE TO CALL IN BY USING THE PHONE NUMBER THAT WILL SCROLL ON THE TV.

MR. TIMOTHY WOODLAND INTRODUCED HIMSELF AND ASKED HIS ATTORNEY TO REVIEW THE PROPOSAL. ATTORNEY ROBERT PETERSON INFORMED THAT MR. WOODLAND BECAME THE OWNER OF THE PROPERTY IN OCTOBER 2020. THERE IS ONE COMMERCIAL UNIT AND TWO EXISTING RESIDENTIAL 2 BEDROOM UNITS ON THE SECOND FLOOR. HE WANTS TO REDEVELOP THE PROPERTY BY REMOVING THE COMMERCIAL ON THE FIRST FLOOR AND IS PROPOSING 3 ADDITIONAL RESIDENTIAL UNITS – 1 TWO-BEDROOM, 1 STUDIO AND 1 ONE-BEDROOM. THE ABUTTING BUILDING IS ALL RESIDENTIAL.

NO ONE SPOKE IN FAVOR OR AGAINST THE PROPOSAL.

HEARING CLOSED.

EACH COUNCILLOR EXPRESSED THEIR VIEW ABOUT THE PROPOSAL. SOME FELT THAT THE FIRST FLOOR SHOULD REMAIN COMMERCIAL. OTHERS SUPPORTED THE PROPOSAL AS THIS BUILDING IS NOT LOCATED IN THE HISTORIC DOWNTOWN AND THE ABUTTING BUILDING IS ALL RESIDENTIAL.

ON MOTION OF COUNCILLOR LEPAGE TO AMEND THE MOTION TO INCLUDE PLANNING DIRECTOR WILLIAM PILLSBURY'S LETTER DATED JANUARY 29, 2021 AND DEPARTMENT HEAD LETTERS WITH SECOND FROM COUNCILLOR MCGONAGLE.

THE MAYOR INFORMED THAT THE OWNERS REFUSE TO FIX UP THE BUILDING AND THEY LIVE IN FLORIDA. AS SOON AS THE CITY BOARDS IT UP VANDALS GET IN. HE HAS USED CDBG FUNDS TO TRY AND MAINTAIN IT. ARCH DEVELOPMENT HAS INDICATED THAT THE PROJECT IS NOT DOABLE WITHOUT SUBSTANTIAL STATE SUBSIDIES. THE WHOLE PACKAGE IS KNOWN AS ONE STOP PERMITTING. THE CITY IS LOOKING INTO TAKING OVER THE DAM PORTION AS ARCH DEVELOPMENT DOES NOT WANT THE DAM. THE MAYOR IS EXPLORING GRANT FUNDING AND LIABILITY ISSUES.

COUNCILLOR MICHITSON ASKED TO DISCUSS PROGRESS ON BRIDGING THE DIGITAL DIVIDE FOR BROADBAND INTERNET ACCESS FOR HAVERHILL AND INTRODUCED REP. ANDY VARGAS TO SPEAK ABOUT THE BILL HE FILED. REP. VARGAS GAVE A POWERPOINT PRESENTATION. REP. VARGAS INFORMED THAT IN DECEMBER COMCAST ANNOUNCED DATA CAP RESTRICTIONS AND THAT THEY WOULD BE CHARGING AN ADDITIONAL \$10 TO \$100. HE FILED THE BILL WITH BI-PARTISION SUPPORT FOR ACCESS PROTECTIONS AND DATA CAPS. COMCAST HAS DELAYED IMPLEMENTATION UNTIL AUGUST FOR MASS CUSTOMERS. THE NEXT STEP IS TO ESTABLISH REGULATORY FRAMEWORK FOR INTERNET SERVICE PROVIDERS (ISP) IN MASSACHUSETTS AND GRANT OPPORTUNITY FOR HOTSPOT SPACES. THE MAYOR INFORMED THAT HE WILL BE PUTTING OUT RFP FOR FIBER NETWORK FOR CITY.
