

# City of Haverhill City Council Minutes Tuesday, May 12, 2020 Virtual Meeting

Present – President Melinda Barrett, Councillors LePage, Bevilacqua, Michitson, Sullivan, Jordan, McGonagle, Daly O'Brien and Macek. City Clerk – Linda L. Koutoulas

President Barrett, Vice President LePage and City Clerk Koutoulas participated from the City Council office.

President Barrett read the following statement: This meeting of the Haverhill City Council is being conducted remotely consistent with Governor Baker's Executive Order of March 12, 2020, due to the current State of Emergency in the Commonwealth due to the outbreak of the "COVID-19 Virus".

In order to mitigate the transmission of the COVID-19 Virus, we have been advised and directed by the Commonwealth to suspend public gatherings, and as such, the Governor's Order suspends the requirement of the Open Meeting Law to have all meetings in a publicly accessible *physical* location. Further, all members of public bodies are allowed and encouraged to participate remotely.

The Order, which you can find posted with agenda materials for this meeting allows public bodies to meet entirely remotely so long as reasonable public access is afforded so that the public can follow along with the deliberations of the meeting.

Ensuring public access does not ensure public participation unless such participation is required by law. This meeting will not feature public comment.

Due to the ongoing COVID-19 Pandemic, Governor Baker issued an Emergency Order temporarily suspending certain provisions of the Open Meeting Law, G.L. c. 30A sec. 20. Public bodies otherwise governed by the OML are temporarily relieved from the requirement that meetings be held in public places, open and physically accessible to the public, so long as measures are taken to ensure public access to the bodies' deliberations "through adequate, alternative means."

Mayor Fiorentini asked to give an update on COVID-19. He informed there are over 919 cases in Haverhill and 29 deaths. The trend is going downward in Haverhill and throughout state. It looks like we are opening on May 18. There are no COVID cases at Merrimack Valley Hospital in Haverhill. We are partnering with Partners in Health via phone to do contact tracing. If you get a call on your phone and it indicates MA COVID 19 please take the call. On May 18th the governor will reveal what businesses will first be allowed to open. Guidelines and checklist will be issued. Social distancing will be required of 6' between people. Restaurants will have distancing/capacity requirements and will not be in first round of openings. The Mayor thanked all for shared sacrifices as this has helped in flattening the curve. This will be a slow and gradual process. Councillors raised questions/concerns about PPE for businesses, clean air/air flow for city hall and schools, ADA compliance, farmer's market status, making Washington Street one-way, assistance for restaurants in terms of extending sidewalks. The Mayor indicated possibility of using parking lots to assist with dining and state to issue guidelines for farmer's market.
