Margaret Conneely appeared on this matter. Mrs. Conneely explained what happened the night of the incident. Lieutenant Pistone of the Haverhill Police Department stated that they have had no problems with this establishment and there were no concerns by the police department. They do not want to infer anything happened if it didn't happen. The Commission was of the opinion that the Licensee had done nothing wrong. SHOW CAUSE HEARING - ALLEGED VIOLATION OF 204 CMR 2.05 (2) PERMITTING AN ILLEGALITY ON THE LICENSED PREMISES, TO WIT: CHAPTER 138, SECTION 69 - SALE OR DELIVERY TO A PERSON UNDER TWENTY ONE YEARS OF AGE ON OR ABOUT JUNE 16 2017

Harshad Patel and Eddie Patel appeared on this matter. Lieutenant Pistone of the Haverhill Police Department summarized the report for the record. This incident arose out of a compliance check being done in the city. The Commission had questions about the employee, why he was not present at the hearing, if he was still employed, the training of the employees and if they were still using the private company they were ordered to use after the last violation and whether there was a system in place to require an identification to make an alcohol purchase. The Licensee is currently looking to install these systems. Motion to suspend the sale of alcohol for three days – Friday September 15, Saturday September 16 and Sunday September 17 2017, to continue the use of a training company for all employees and probation for six months. If a violation occurs during this 6 months, they will re-evaluate this penalty and assess a penalty for the new violation made by Commissioner Coco, seconded by Commissioner Sewell. No public comment on this matter. Vote unanimous, motion passed.

Shamrock Haverhill, Inc., d/b/a Shamrock Likkers 400 Lowell Avenue #6

Show Cause Hearing - Alleged Violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: Chapter 138, Section 69 - Sale or delivery to a person under twenty one years of age on or about June 16 2017

Richard Comeau appeared on this matter. Lieutenant Pistone of the Haverhill Police Department summarized the report for the record. This incident arose out of a compliance check being done in the city. Mr. Comeau indicated that he takes this matter very serious. Although he visits the issue of checking IDs every day, he has placed identification scanners at each register and he is re-enrolling everyone in a TIPS class and is requiring them to take it again every year, even though the certificates are good for four years. He indicated that there were three stings that night and they passed the other two without a problem. Not trying to give excuses, but the person who sold the alcohol was distracted at the time. Mr. Peter Hurn, who sold the alcohol, was available to speak to the Commission. He deeply regrets that night and would do anything to take it back. Motion to place the establishment on probation for three (3) years, if another violation of this kind, sale or delivery to a person under 21, occurs there will be a three day suspension of alcohol sales and a new punishment to be considered for the new violation made by Commissioner Coco, seconded by Commissioner Sewell. No public comment on this matter. Vote unanimous, motion passed.

PIERRE I EL HAYEK, D/B/A TOPLINE IMPORTS 534 RIVER STREET

SHOW CAUSE HEARING - ALLOWING MORE CARS FOR SALE OR SERVICE ON THE LOT THAN THE NUMBER SET FORTH ON THE LICENSE ISSUED BY THE CITY OF HAVERHILL. NOT ALLOWING PROPER SPACE FOR CUSTOMERS AND EMPLOYEES

Attorney Anthony Bisone and Pierre El Hayek appeared on this matter. Lieutenant Pistone of the Haverhill Police Department summarized the report for the record. Officer Lance Powell also spoke about the matter. The Commission questioned how many cars should be on the lot, if there is a problem with cars blocking and if there was room on the lot for fire apparatus. John Powers, owner of the lot spoke in support of Mr. El Hayek, but he was more concerned with not being able to park on Florence Avenue. Attorney Bisone stated that Mr. El Hayek instructs people not to park on Florence Avenue. He had a busy summer and fixes all the cars that come back to him. It is difficult to determine how many cars are coming in for service. He is looking for alternatives for parking the cars that are there for service. Motion to revisit this matter in November, Officer Powell to check on this business in the interim and report to the Commission made by Commissioner Sewell, seconded by Commissioner Coco. No public comment on this matter. Vote unanimous, motion passed.
