Commissioner Driscoll inquired if the future owners had TIPS certifications and experience with ABCC requirements. Mr. Jackson said his wife has been a bar manager for 11 years. Commissioner Koutoulas advised that all personnel touching alcohol needed to be TIPS certified – Mr. Jackson said he was aware and they would also be using ServSafe Alcohol.
