She noted once fully implemented the lease is expected to be cost neutral. This approach supports the needs of our schools and students.

Superintendent Marotta addressed the council. She noted this will be revenue neutral with the idea of reducing the need to send students out of district. Additionally, the program is expected to add about 25 students at a cost of \$8,000.

Councilor Lewandowski asked if this was the school expansion she mentioned during the budget hearings that out of district students could apply to and we could get tuition from. Superintendent Marotta confirmed. President Sullivan noted for the record this lease is \$180,000 a year for the next 5 years.

Councilor Lewandowski stated she wanted to thank departments that worked hard to reduce costs. At the same time, grappling with conflicting concerns while disappointed that taxpayers will see another increase, I also recognize the need to move forward to avoid cuts to essential services. She noted she will be voting in favor of this budget but strongly urged exploring adjustments to major items like health insurance, legal and overtime. She would also include in the exploration grant funding.

Councilor Basiliere stated he appreciated Councilor Lewandowski's comments. He wanted confirmation that the total budget would be 277 million dollars. President Sullivan confirmed.

Vice President Jordan stated he appreciates the collaborative effort among everyone, city staff, councilors, the Mayor addressing budget challenges. He noted he supports tax relief for lower income seniors, and he looks forward to these changes being included in future budgets to help those who need it most. He stated he also intends to vote for the budget.

Photos shown during the meeting depicted the property as cluttered. Due to the ongoing court case, unresolved concerns, and lack of clarity from inspections, most councilors were not prepared to support the request at this time.
