PLACED ON FILE

MAYOR FIORENTINI INFORMED THAT THE CITY MADE AN EFFORT 18-20 YEARS AGO TO SELL THE LAND. THEY RECEIVED 3 PROPOSALS FOR THE NEWLY ISSUED RFP. BIDS WERE FROM NOAH, BEACON PROPERTES/PRINCETON AND PROCOPIO COMPANIES. HE INTRODUCED MICHAEL PROCOPIO WHO GAVE AN OVERVIEW OF HIS TEAM CREDENTIALS AND GATEWAY CITY PROJECTS THAT PROCOPIO PROPERTIES HAVE DEVELOPED.*

THE CITY CONSULTED WITH UTILE FOR THE RFP REVIEW. TIM LOVE AND WILL COHEN GAVE A POWERPOINT PRESENTATION OF HIGH-LEVEL CROSS COMPARISONS OF THE 3 BIDS. PROCOPIO COMPANIES IS THE PREFERRED DEVELOPER. THE PROPOSED PROJECT HAS 290 UNITS AT 100% MARKET RATE RENTALS WITH NO SUBSIDIES. IT IS NOT GEARED TOWARD FAMILIES. THE PROJECT WILL INCLUDE SKATELAND SITE AND ALL PROPERTIES UP TO THE BRIDGE.

THE MAYOR INFORMED THAT HE CAN DESIGNATE THE PROCOPIO COMPANIES AS THE PREFERRED DEVELOPER AND THAT HE IS ONLY ASKING THE COUNCIL TO DECLARE THE PROPERTY SURPLUS. THE MAYOR WILL NEGOTIATE WITH PROCOPIO. COUNCILLORS RAISED ISSSUES OF TRANSPORTATION, PUBLIC SAFETY, INFRASTRUCTURE AND IMPACT TO THE AREA. IT WAS AGREED THAT MORE HOMEWORK HAS TO BE DONE REGARDING TRANSPOR-TATION.
