Steve Dorrance spoke of work being done over last six months which include school building HVAC air conditioning and heat working; energy improvements in cooperation with National Grid upgrading the 24 VFD devices not working, school granted \$175K and \$9K rebates per school; Boiler upgrades; doing away with switches

A/C issues with other 4 "cookie cutter" schools; 11 dead compressors, use R22 no longer available, all units need to be replaced approximately \$800K per school; building of new animal shelter; Police canopy project

Councillors' comments include what steps can be taken to move forward; schedule plan for replacements of major items; clarification on Dorrance's time for capital projects for entire city not just schools; better communication between school and city; hired contractors should be held accountable; joint facilities committee

Councillor Jordan asks about Dorrance's salary percentage city vs school dept.

Chuck Benevento clarifies an internal journal entry will be done at end July when warrants open

Councillor Jordan requests an update in two weeks to confirm transfer was made
