Overview of Markets and Performance Report

There have been some Putnam Investment recommended changes in the agreement that will be reviewed, discussed and voted on at the September 10, 2024 board meeting.

A motion was made by Perkins to withdraw \$300,000.00 from Income Research+Management (IR&M) needed for the August 2024 Warrant, seconded by Haugh.

• Investment Policy Statement Review (IPS)

In addition, Mr. Van Dam will also take \$300,000 from Income Research+Management (IR&M) to cover future capital calls.
